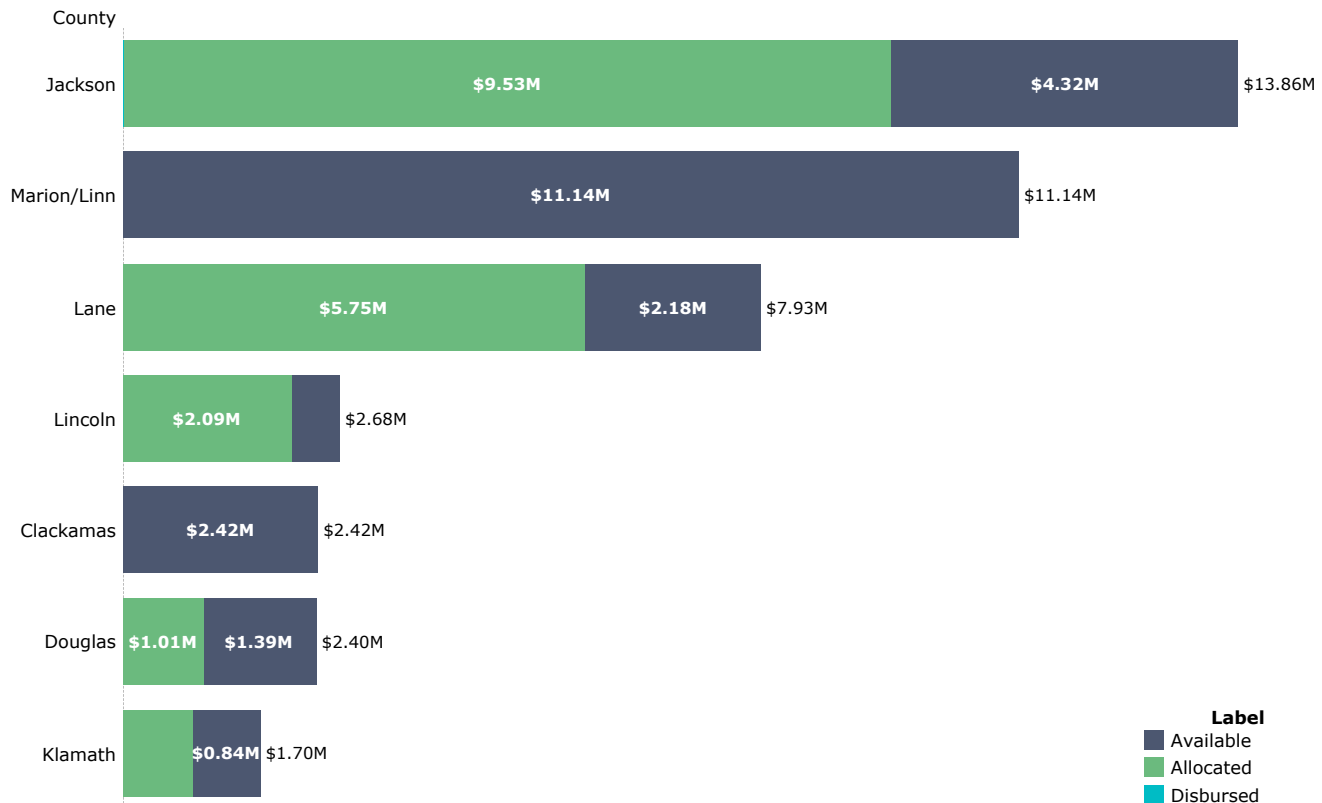

Project Under Review by OHCS	Chiloquin Fire & Rescue	This project will purchase a Class A Pumper fire truck to replace the existing truck, and update the Chiloquin Fire and Rescue station, which will include new bay areas for storage of fire apparatus for community protection.
McKenzie School District HVAC	Lane	02. Project Approved by OHCS	Lane County	The McKenzie School District infrastructure project will upgrade the HVAC systems in the elementary and high school buildings. The goal of the project will be to ensure that the schools have efficient systems with the capacity to cool the buildings and provide filtered air for students and the community in emergency sheltering situations.

The goal of the project will be to provide emergency power when the buildings are used as emergency shelters during disasters.
Talent West Valley View Plan Upgrade & Revitalization	Jackson	03. Project Active	City of Talent	The City of Talent's infrastructure project will include the Wagner Street alignment and extension from Talent Avenue to the Talent Irrigation District's west property boundary; utility replacement, curbing, gutters, sidewalks, and street paving on Gangnes Drive (Loop) to establish a secondary connection to the Gateway site; and retrofit of the Gateway site to remove temporary use infrastructure and replace it with permanent utilities. The goal of the project is to facilitate the recovery of the West Valley View area by attracting development and supporting economic revitalization for long-term recovery to support permanent housing, mixed-use housing, open space, and retail development.
City of Chiloquin Public Works	Klamath	03. Project Active	City of Chiloquin	The Chiloquin public works infrastructure project will construct a new public works facility. The goal of the project is to accommodate equipment, supplies, and maintenance needs to improve operational efficiency during emergency response.
IVCDO Capital for Small Businesses & Microenterprises	Jackson	03. Project Active	Illinois Valley Community Development Organization (IVCDO)	IVCDO will provide grants and loans to small and microenterprise businesses to address the unmet needs of smaller businesses looking to launch or expand. IVCDO also will provide grants and loans to microenterprises that have lacked the capacity to apply for more competitive awards. The project includes the expansion of IVCDO's existing Small Business Revolving Loan Fund to include lower interest rates (< 5%), a local presence, flexibility, reasonable administration fees, and the creation of a Microenterprise Grant program that includes up to \$15,000 grants with expedited turnaround after approval.
