Update For: Finalizing 21-23 biennium and beginning 23-25

Message: Following up on the message that was shared with last month and provide a critical update. In the previous message it was stated that agencies had "until <u>08/25/23</u> to submit requests for funds and <u>08/30/23</u> to submit your final FSR (Financial Status Report) in OPUS." The clarifying point here is that agencies have until <u>08/30/23</u> to submit Request for Funds (RFFs) and to submit your Final Financial Status Report (Final FSR) in OPUS.

Additionally, we wanted to provide a friendly reminder that Requests for Funds (RFFs) in OPUS require backup to substantiate our disbursements. Without proper backup, the RFF <u>may be returned to you for resubmission</u>.

This year, our auditors reminded us of the following:

- When providing Expended to Date amounts, information from the general ledger should be attached that supports the amount to be funded.
- Projected amounts need to provide specific information within the Comments area to support the advance that is being funded.
  - Examples of comments that are acceptable:
    - 06-6032-21-20-4060-6000 Batch #108997
    - Payroll Batch 103667 \$9740; Vendors Batch 1015335 \$4860
    - We have approved client applications for 15 households totaling \$4,250 that are in process of being paid
  - Examples of comments that are not acceptable:
    - 'Bills to be paid xx/xx/2023
    - Interim payment
    - Blank
  - For Direct Client Vendor payments, listing the batch numbers that the funds will support is preferred.
- When providing Expended to Date information and including a Projected amount, general ledger backup <u>and</u> a detailed comment must both be included.

We appreciate your ongoing assistance and patience as we conclude one biennium and start another biennium. Please do not hesitate to reach out to any of the Program Analysts within the Homeless Services Section or the Fiscal Department with any follow up comments, questions, or concerns.

Update For: Finalizing 21-23 biennium and beginning 23-25

**Message:** This is an update to inform you of the details for rolling up this last biennium and starting with our new one. Below is a table of all the HSS grants that will or will not roll funds into the 23-25 biennium. Not every HSS grant is identified in this list; however, if you have questions about any specific grant, please let us know.

Whether you have funds in a grant that will roll or will not roll, the expenditure period of all of these funds ends 06/30/23. Please be sure that all work is performed, and all purchases are received by 06/30/23.

You have until <u>08/25/23</u> to submit requests for funds and <u>08/30/23</u> to submit your final FSR (Financial Status Report) in OPUS.

If you wish to move funds between categories prior to your final draw and the submission of your final FSR, then you must submit a <u>budget change request</u> by no later than **08/11/23** in order to ensure there is sufficient time to process your BCR. <u>All final draws (RFFs) must be submitted by 08/25/23</u>.

As we transition into the 23-25 biennium, we are currently in the final processing stages of the IRs and Budgets in Smartsheet. Communications have already been sent out to individual agencies regarding insufficiencies related to the required documents. Program documents that are unapproved will restrict OHCS' ability to approve a request for funds for that program in the coming biennium. Required polices that are unapproved will restrict OHCS' ability to approve requests for all HSS programs Please be sure to respond to those requests in a timely manner in order to meet your needs for 2023-24 funding.
