Housing Stabilization Division



MISSION:

The Housing Stabilization Division develops racially just policies and funds services through partnerships which prevent and reduce housing/energy insecurity and houselessness for underserved communities. We strive for housing and energy stability for all Oregonians.


VISION:

All Oregonians will have equitable and inclusive access to safe and affordable housing and energy resources ensuring that any experience of housing instability will be rare, brief, and nonrecurring.

Where we Have Been....

- Small staff, focused on pass-through, primarily federal funding
- Formula funding almost exclusively to the CAA Network
- •Funding oriented to allowable uses, not to specific and measurable outcomes.
- •HB 2100 and SB 893 provide mandate to create an intentional **system** focused on providing solutions for housing instability and homelessness


2025 July Start of 2025-27 biennium and deadline for implementation

Racially Equitable Outcomes Directed Funding Implementation Plan

We MUST

- 1. Prepare HSD as both a funder and a partner.
- 2. Understand the current state of homelessness and housing instability.
- 3. Identify and invest in specific best practices that reduce disparities
 - Street outreach and Navigation
 - Shelter
 - Housing (responsive to individual need)
 - Stabilization and Prevention
- 4. Create an equitable procurement and funding strategy
