Current OHCS Funding Updates: Sam Kenney

OHCS is working to dispersing COVID-19 relief funds to local partners. \$12 Million dollars have been allocated to OHCS through the State Legislator; \$8.5 Million is towards safe sheltering and rental assistance. \$3.5 Million is dedicated to Agriculture Farmworkers and others experiencing homelessness. These funds have been dispersed using the same Master Grant Agreement to the Community Action Agencies.

\$8.5M in Rent Relief Program will be dispersed to Community Action Agencies, using the existing Master Grant Agreement with a needs-based formula to properly allocate throughout the state. The major difference between these new Rent Relief funds is that there is an addition to include COVID-19 data, and help to target hardest hit communities. The program serves at income levels at 50%AMI. We are working with partners to have a quick turn around on grand agreements but we ask for you reach out if you are having an issues that need addressing.

\$3.5M Safe Sheltering and can be used for farmworkers and other experiencing homelessness. Latino communities have been disproportionately impacted by the COVID-19 pandemic so the intent with these new funds is to mitigate and reserves some of these disturbing trends. OHCS will be working directly with cultural specific organizations, continuum of care offices, and service providers to learn more about the needs' of Oregon's farmworkers and drive the use of these funds. The Governor's office has put together an Agriculture Worker Taskforce to work on the Safe Shelter allocation going to this community. Emergency Solutions Grant (ESG), Emergency Housing Assistance Program, State Homeless Assistance Program, as well as other one-time shelter funding that are all available now because of the current COVID-19 health crisis. There will be a number of follow up webinars to answer questions about how to utilize these funds and to answer any questions you may be having.

Oregon Legislature Emergency Board is convening this afternoon and we are expecting more rental assistance and other resources. More to come.

<u>Regional Area Updates:</u> Successes this week, and anticipated challenges.

Deschutes/Crook/Jefferson: , we have taking over operations of our hotel in Bend this week for isolation purposes. We are working on getting high risk folks placed using an adapted coordinated entry system.

Outreach to individuals is continuing providing our Mobile medical van, dental van, shower truck, providing hand washing stations, PPE, food, water etc

We are seeing an increase in individuals experiencing homelessness across the region and are navigating complaints from community members and working with LE agencies not to sweep encampments.

Rental assistance is going out the door, although it has been a struggle with the 50% AMI cap.

- Marion/Polk: Unemployment is current at 13% so they a mobilizing with local partners to make sure these funds are brought out the door. We support the increase of AMI increase from the eBoard to 80% MFI.
 - Question related to local/entitlement CDBG and for clarification, CDBG Entitlements resources go to communities with a population of over 50K or greater. These are listed on the HUD Exchange. This resource is a Block grant and does not dictate what the resource must be used for but has to meet basic objectives. Rental assistance can be made under Public Services but is currently only available for up to 3 months. Again this determination is made at the local level by those entitlement CDBG grantees.
- Washington: Respite shelter have housed 5 and 2 that will be transitioning into permanent housing. Currently expanding this shelter to encompass those that have been in contact with COVID and are unsheltered. CARES Act funds are approved at local county level. Prevention is also being looked at in encampments. Rent Relief efforts still remain a priority of work in this area. Currently working in reopening phase 2.
- Klamath/ Lake: Housing of COVID positive communities members that are not able to isolate are being prioritized Pubic Health so that staff can then focus on getting the rent relief funds out the door. We have been shifting staff to help with getting these resources to the community. Currently working in reopening phase 2.
- Hood River: thankful for the shared information across the state. Winter warming shelter is being moved, it will not be available for next year.
- Umatilla: Discontinuing hotel/motel funding is out on the 24th. Will be able to assist if there is anyone that does test positive in the future. We echo the AMI lift to 80% from the current 50%.
- Linn/ Benton: Rent Relief is being pushed out, new applicants that have not ever had to request assistance are now navigating the request process. New RV camp site is now available for those in need. Has seen a COVID increase since tourism has

resumed. Hotel/motel vouchers are still being utilized for COVID positive situations. Farms are now developing Safe Shelters for those in need to safe options.
