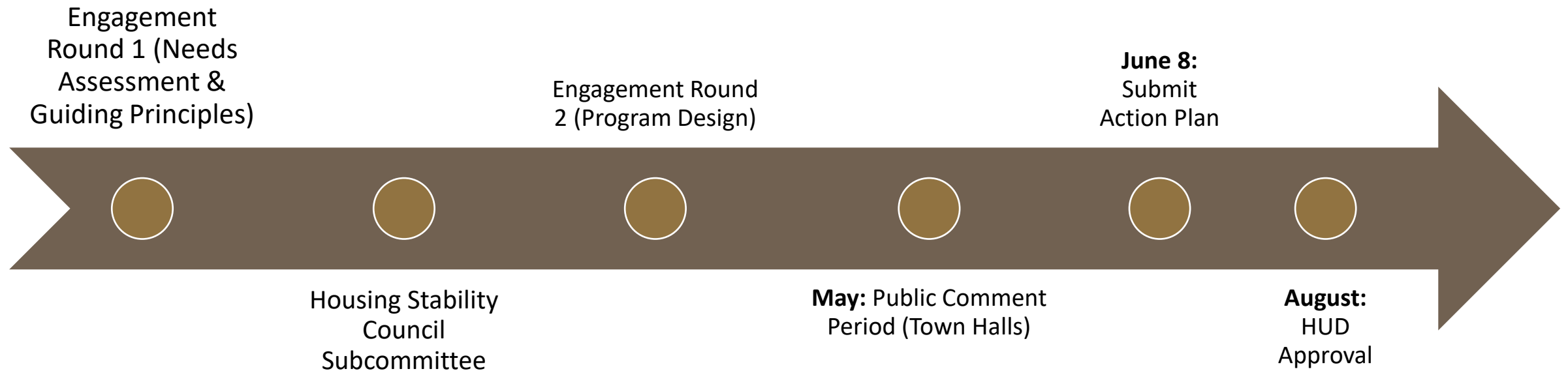

Disaster Recovery Rules

Total allocation: **\$422,286,000**

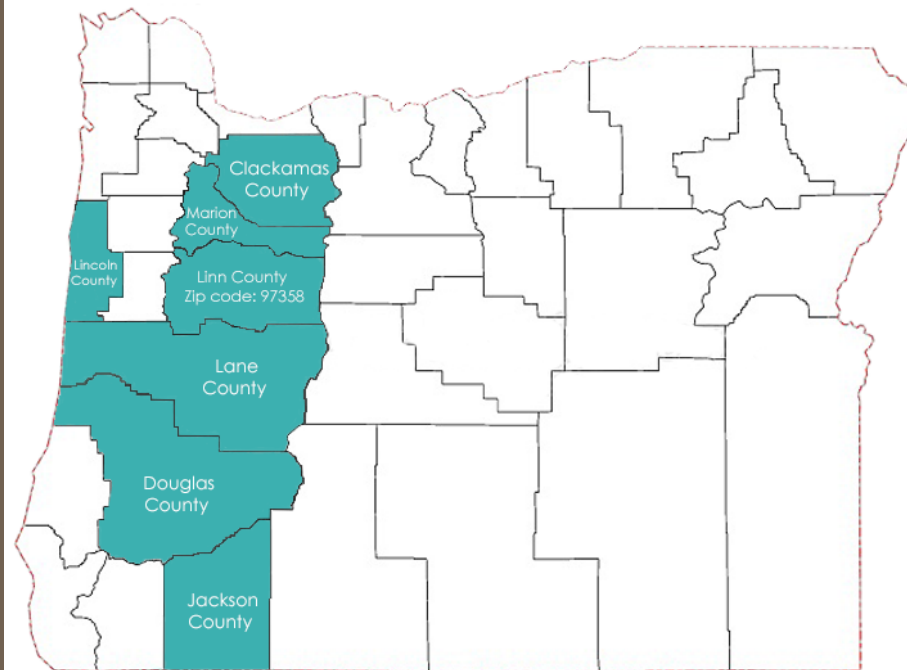
At least 70% of funds must benefit **low-to-moderate income (LMI)** persons or households.

At least 80% of spending in **Most Impacted and Distressed (MID) counties**.

Direct delivery of services is allowed.

At least 15% for mitigation
