2022 BEVERAGE CONTAINER RETURN DATA

ORS 459A.718(6)(a) states that by August 1 of each calendar year, the Oregon Liquor and Cannabis Commission shall calculate the previous calendar year's percentage of beverage containers returned for the refund value for each distributor cooperative and for each distributor/importer that does not participate in a distributor cooperative. The OLCC shall carry out the calculation separately for glass, metal, and plastic containers and shall post the percentages on the Commission's website.
