 - *Alcohol Delivery Package*
 - *The rules within this package contemplate three issues: curbside delivery, extended hours of sale of alcoholic beverages (6:00am) to accommodate vulnerable populations and fast tracking delivery approval for businesses already holding a license to sell alcoholic beverages.*
 - *Marijuana Licensing and Delivery Package*
 - *The changes to OAR 845-025-1090 enable the Commission to assert discretion over the need to conduct a pre-licensing inspection in order to prevent unnecessary contact between licensees and staff. The amendments allow for the Commission to conduct an inspection if it is deemed necessary.*
 - *The package deals with the proposed permanent adoption of OAR 845-025-2885, which enables licensees to provide “on-site” delivery to patrons.*
