  - ***Marijuana License Moratorium*** Action  
Permanently amend OAR 845-025-1131 & OAR 025-1132, which impose a moratorium on new producer, processor, wholesaler, and retailer license applications received after January 1, 2022. The moratorium will remain in effect until March 31, 2024.
  - ***Reporting Sex & Human Trafficking at Marijuana Licensed Premises*** Action  
Permanently adopt OAR 845-025-5585, which requires employees or workers at a marijuana-licensed premises to report if there is a reasonable belief that sex trafficking or other human trafficking is occurring at the premises. Employees or workers must also report if they have a reasonable belief that a minor is employed or contracted at the premises in a manner that violates OLCC rules.
