## **OLCC Commission Approves Restricted Marijuana License, Marijuana Licensee Stipulated Settlements**

**PORTLAND, OR.** – At its **regular monthly meeting on July 16, 2020**, the Oregon Liquor Control Commission agreed to an application for a producer marijuana license and approved four marijuana violation stipulated settlement agreements.

The Commission approved a recreational marijuana producer license for Jreims Fields, LLC, but restricts the landlord for the property from taking part in the operation or management of the business; another condition for licensure is that the landlord will not be allowed to be on the licensed premises.

The landlord, Kevin Blum, has a financial interest in the business as the property owner; Blum has a poor record of compliance with the Commission which led to the surrender of his recreational marijuana retail license.

The applicant, Justin Reimers, doing business as Jreims Fields, accepts the license restrictions.

The Commission also ratified the following violation fines and suspensions based on stipulated settlements (*detailed information on specific cases can be found [here on the OLCC website](#)*):

**WM Ranch** will pay a fine of \$1,485 **OR** serve a nine-day recreational marijuana producer license suspension for one violation.

Licensee is: WM Ranch LLC; Kenneth Clarke, Member; Alice Clarke, Member.

**TODAY'S HERBAL CHOICE FREMONT** in **Portland** will pay a fine of \$4,950 **OR** serve a 30-day recreational marijuana retailer license suspension for one violation.

Licensees are: Today's Herbal Choice Fremont, LLC; Merle Thomas, Managing Member; Timothy Ray, Member.

**CANNABEND in Bend** will pay a fine of \$11,650 OR pay a fine of \$10,000 AND serve a 10-day recreational marijuana retailer license suspension for two violations.
