Locations Proposed for Retail Liquor Stores Across Tri-County Area

OLCC receives 53 applications for eight potential locations in Clackamas, Multnomah and Washington counties

Portland, OR -- The Oregon Liquor Control Commission has received 53 applications for proposed retail liquor locations in Multnomah, Clackamas and Washington counties. The Commission will select proposals for up to eight new locations.

OLCC Commissioners will accept written public comment beginning Thursday, April 22nd through 5:00 p.m. Wednesday May 12th. Comments can be sent via email to OLCC.RetailServices@Oregon.gov or by postal mail to OLCC Retail Services, PO Box 22297, Milwaukie, OR 97269-2297.

The Commissioners will review comments submitted and will make final decisions based on their legal authority. Applicants will have an opportunity present their proposals to the Commissioners May 26 and 27, 2021. The names of the 53 applicants and their proposed locations are listed below.
