## Commission names Interim Executive Director Craig Prins will guide agency's course correction

**PORTLAND, Ore.** – The Oregon Liquor and Cannabis Commission (OLCC), at its regularly scheduled monthly meeting **on February 15, 2023**, appointed Craig Prins as the agency's interim Executive Director.

Commissioners also renewed contracts with independently operated liquor store businesses, updated advertising rules for liquor stores, and selected new liquor store products to be sold in Oregon stores.

The Commission also ratified 12 stipulated settlement agreements for both alcohol and marijuana licensees. Detailed information on the specific cases below can be found [on the OLCC website](#):

### **Alcohol Stipulated Settlement Agreements**

**1960 COCINA (F-COM)** in Eugene, will pay a \$2,250 fine OR serve a nine-day license suspension for one violation.

**CHUCKIE PIES (F-COM)** in Lake Oswego, will pay a \$2,250 fine OR serve nine-day license suspension for one violation.

**LITTLE'S MARKET & DELI (O)** in Eugene, will pay a \$2,250 fine OR serve nine-day license suspension for one violation.

**NEIGHBORHOOD MARKET (O)** in Eugene, will pay a \$2,250 fine OR serve nine-day license suspension for one violation.

**PURLIEU (F-COM)** in Eugene, will pay a \$4,065 fine OR serve 20-day license suspension for two violations.

**SUAVECITO BAR & GRILL (F-COM)** in Portland, will serve a 43-day license suspension OR pay a \$3,630 fine AND serve a 21-day license suspension for three violations.

**CHOPS BISTRO (F-COM)** in Sisters, will serve a 47-day license suspension OR pay a \$3,960 fine AND serve a 23-day license suspension for three violations.

**CAROLE'S MAD DOG RESTAURANT AND SALOON (F-COM)** in Sumpter, will pay a \$1,485 fine OR serve a nine-day license suspension for one violation.

**TOWN & COUNTRY LANES (L-NP)** in Keizer, will pay a \$4,620 fine AND serve a two-day license suspension OR serve a 30-day license suspension for one violation.

**SPORTSMAN TAVERN (F-COM)** in Cave Junction, will install age verification that meets Commission standards AND pay a \$12,885 fine AND serve a seven-day license suspension OR serve an 82-day license suspension; but if it does not install age verification that meets Commission standards it shall pay a \$15,385 fine AND serve a seven-day license suspension OR serve an 92-day license suspension, for five violations. Licensee also accepts license restrictions.

#### **Marijuana Stipulated Settlement Agreements**

**JEFFREY VILLANUEVA (WP)**, will pay an \$800 fine AND serve a 21-day permit suspension OR serve a 53-day permit suspension for two violations.

**THURMAN STREET COLLECTIVE (Retailer) in Portland**, will pay a \$4,500 fine AND serve a two-day license suspension OR serve a 20-day license suspension for one violation.
