### **Marijuana License Moratorium & Reporting of Sex & Human Trafficking at Licensed Premises**

**License Moratorium:** The 2022 Oregon Legislature passed House Bill 4016, of which Section 1 imposes a moratorium on new producer, processor, wholesaler, and retailer applications. The legislation requires that OLCC inactivate new applications received after January 1, 2022 for these license types. For applications received on or before January 1, 2022, applicants must timely submit a land use compatibility statement, and applicants may not change location or ownership of these applications.

This section of House Bill 4016 is effective upon passage, which requires OLCC to pass temporary rules to implement the license moratorium. The moratorium is in effect until March 31, 2024.

**Reporting of Sex & Human Trafficking at Licensed Premises:** The 2022 Oregon Legislature passed House Bill 4074, of which Section 2 sets requirements for reporting sex trafficking or other human trafficking. Employees or workers at a marijuana-licensed premises must report to a law enforcement agency or the OLCC if the employee or worker has a reasonable belief that sex trafficking or other human trafficking is occurring at the premises. Employees or workers must also report if they have a reasonable belief that a minor is employed or contracted at the premises in a manner that violates OLCC rules.

This section of House Bill 4074 is effective upon passage, which requires OLCC to adopt a temporary rule to implement the legislation.
