During the 2019 Oregon Legislative session, the Oregon Legislature passed SB 829 which requires the Commission to collaborate with the wine industry to adopt rules related to the labeling of nested American Viticultural Areas (AVAs.)
- ***Final Action*** *Action*
 - ***2019 Division 25 and Technical Package***
During the 2019 Oregon Legislative session, the Oregon Legislature made changes to the marijuana provisions of Chapter 845. This rule package addresses both the changes made during legislative session and technical issues that have arisen during the management of the regulated marijuana program.
