**Definitions in Oregon for malt beverage, wine, and cider**

- **Malt Beverage** is made from the fermentation of grain and contains not more than 14% alcohol.
- **Wine** is made via the fermentation process, is not a cider or malt beverage, and contains not more than 21% alcohol by volume.  
Note: cider containing more than 7% alcohol is considered wine.
- **Cider** is made from the fermentation of the juice of apples or pears and contains not more than 8.5% alcohol.

**Same-Day or Next-Day Delivery?**

“Same-day delivery” means you cause a resident of Oregon to receive malt beverages, wine, or cider on the same day you receive the order from the customer.

“Next-day delivery” means you cause a resident of Oregon to receive malt beverages, wine, or cider after the day you receive the order from the customer.

**Oregon Licensees Making Next-Day Delivery**

The following licensees automatically have the privilege of making next-day delivery of the type of malt beverages, wine, and cider that the license allows: Brewery, Brewery-Public House, Growers Sales Privilege, Off-Premises, Winery licensee with a valid TTB Producer and Blender Basic Permit, and Winery licensee with a valid TTB Wholesaler Basic Permit

**Oregon Licensees Making Same-Day Delivery**

The following Oregon licensees are eligible to obtain approval to make same-day delivery of the type of malt beverages, wine, and cider that the license allows:

- Brewery licensee: may use this form to apply to deliver malt beverages, wine, and cider.
- Brewery-Public House licensee: may use this form to apply to deliver malt beverages, wine, and cider.
- Growers Sales Privilege: may use this form to apply to deliver wine or cider, but only wine or cider where all of the fruit or grapes used to make the wine or cider are grown in Oregon under the control of the licensee.
- Off-Premises Sales licensee: may use this form to apply to deliver malt beverages, wine, and cider.
- Winery licensee with a valid TTB Producer and Blender Basic Permit: may use this form to apply to deliver malt beverages, wine, and cider.
- Winery licensee with a valid TTB Wholesaler Basic Permit: may use this form to apply to deliver malt beverages and may apply to deliver wine or cider brands under the control of the licensee.

**SAME-DAY DELIVERY OF MALT BEVERAGES, WINE, OR CIDER FOR OREGON LICENSEES**



“Same-day delivery” means you cause a resident of Oregon to receive malt beverages, wine, or cider on the same day you receive the order from the customer.
