OLCC Commissioners Ratify Stipulated Settlements for Liquor Violations

PORTLAND, OR – At its monthly meeting March 22, 2018, the Commissioners of the Oregon Liquor Control Commission ratified the following fines and liquor license suspensions based on stipulated settlement:

Portway Tavern, 7600 N. Willamette Blvd., Portland; will pay a fine of \$1,485 or serve a nine-day liquor license for failing to meet the food service requirements for a Full On-Premises Sales license. Licensee is Val 325, LLC; Helen Gibson and Dwayne Gibson, members.

Palmers Cafe, 645 NE Greenwood Ave, Bend; will pay a fine of \$4,950 or serve a 30-day liquor license suspension for failing to maintain liquor liability insurance or a bond in the amount of \$300,000 or more. Licensee is Palmers Diner, LLC; David Chapman, member.

Lil Cooperstown Pub & Grill, 1817 Willamette Falls Drive, West Linn; will pay a fine of \$1,980 or serve a 12-day liquor license suspension for the licensee drinking alcohol while on duty at the licensed premises. Licensee is Icon Cooperstown, LLC; Icon Hospitality, LLC, Icon Construction & Development, LLC, and Mark Handris, members.

NYX, 215 W Burnside, Portland; has surrendered its liquor license for three violations. The first violation is for failing to comply with license restrictions when an employee was placed on duty with an expired DPSST certification. The second violation is for permitting unlawful activity when an employee provided private security services without being certified to do so. The third violation is for an employee concealing potential evidence. Licensee is Jupiter Group, LLC; Jupiter Desphy VII, Joel Priest, and Andrew Miguel, members.

Commissioners ratified the following stipulated settlements for failing to verify the age of a minor before allowing him/her to buy or be served an alcoholic beverage when he/she reasonably appeared to be under 26 years of age.

Cedar Hills Mart & Mail, 10170 SW Park Way, Portland, will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is JEJ Corporation; Jonathan Yu and Inyong Yu, corporate principals.

Ixtapa West Linn, 2000 SW 8th Avenue, Suite F, West Linn, will install age verification equipment to verify the age of anyone purchasing alcohol who appears under 26 years old. Licensee will also pay a fine of \$330 or serve a two-day liquor license suspension. Licensee is Ixtapa RG, Inc.; Gregorio Barajas and Rosa Barajas, corporate principals.

26th Street Superette, 2531 Monroe St NW, Corvallis, will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is Brooke Yim.

7-Eleven Store #2362-16572F, 19175 SW TV Hwy., Aloha, will pay a \$1,155 civil penalty or serve a seven-day suspension. Licensee is Akum Corporation; Mohanbir Grewal and Narinder Grewal, corporate principals.

7-Eleven Store #2362-25458D, 17771 SW TV Hwy., Aloha, will pay a \$3,795 civil penalty or serve a 23-day suspension. Licensee is Kashi, Inc.; Saedeh Bashi and Houshang Kavianian, corporate principals.
