## OLCC Commissioners Ratify Stipulated Settlements for Liquor Violations

**PORTLAND, OR** – At its monthly meeting May 17, 2018, the Commissioners of the Oregon Liquor Control Commission ratified the following fines and liquor license suspensions based on stipulated settlement:

Commissioners ratified the following fines and liquor license suspensions based on stipulated settlement:

**Fortune Star**, 15920 SE Division, Portland, will serve a 50-day liquor license suspension beginning June 20, 2018 and ending August 9, 2018 for two violations. The first violation is for failure to verify the age of a minor before allowing her to buy or be served alcoholic beverages when she reasonably under 26 years of age; the second violation is for permitting a minor to drink alcoholic beverages on the licensed premises. Licensee is Jumbo Company, LLC; Zi-Bo Yu, member.

**Maddy's**, 17102 SE Powell Blvd., Suite E, Portland, will serve a 20-day license suspension or a \$3,300 civil penalty for three violations. The first violation is for failure to verify the age of a minor before allowing him to buy or be served alcoholic beverages when she reasonably under 26 years of age; the second violation is for permitting a minor to be on the licensed premises or in an area of the licensed premises that is prohibited to minors; the third is for permitting patrons to take open containers of alcoholic beverages from the licensed premises. Licensee is 702 Investment Holdings, Inc.; Shane Zack, corporate principal.

**Daily Double**, 617 NE 102<sup>nd</sup> Ave., Portland, will pay a \$2,640 civil penalty or serve a 16-day suspension for two violations. The first is for failing to meet the dining requirements for a Full On-Premises Sales license; the second is for permitting alcohol to be consumed at an outdoor seating area that is associated with the licensed business without the OLCC having approved the sale or service of alcohol in that area. Licensee is STA Corp.; Larry Olsen, member.

**Granite Taphouse**, 23 N. Main St., Ashland, will pay a \$4,950 civil penalty or serve a 30-day suspension for selling or offering for sale alcoholic beverages at an off-site event without obtaining a Temporary Use of An Annual License. Licensee is Granite Taphouse, LLC; Marco Travers, member.

**Amalfi's Italian Restaurant**, 4703 NE Fremont, Portland, will pay a \$4,950 civil penalty or serve a 30-day license suspension of its Full On-Premises Sales License; and serve a 30-day suspension of the Off-Premises Sales License beginning June 20, 2018 and ending July 20, 2018 for selling or offering to sell distilled spirits contrary to the terms of the licensee's Full On-Premises and Off-Premises Sales Licenses, by offering or selling mixed beverages containing distilled spirits for off-premises consumption. Licensee is Amalfi's Italian Restaurant and Catering, Inc.; Kiauna Floyd, corporate principal.

**King's Wild Bar & Grill**, 13550 SE Powell St., Portland, will surrender its Full On-Premises Sales license and accept a letter of reprimand for four violations. The first is for failure to exercise license privileges in compliance with a license restriction when they failed to conduct a search for weapons using an operational metal detector device or wand; the second is for failing to exercise license privileges in compliance with a license restriction when they failed to maintain a DPSST certified security guard at the patio entry/exit from the premises to monitor entry and exit from the premises. The third violation is for failing to exercise license privileges in compliance with a license restriction when they failed to have one DPSST certified security guard on duty to monitor the interior and exterior of the premises and patrol the parking lot every 15 minutes to monitor activity and discourage loitering and illegal activity, and the fourth violation is for failing to exercise license privileges in compliance with a license restriction when they failed to maintain surveillance footage for a minimum of 30 days and failed to make the video surveillance footage available and unaltered to OLCC inspectors after requests from OLCC inspectors. Licensee is King's Wild Bar & Grill, LLC; Andy Maes, member.

**Midnite Sports Bar & Grill**, 3960 Center St, NE, Salem, will pay a \$1,485 civil penalty and serve a 21-day suspension, or serve a 30-day suspension for a history of serious and persistent problems involving disturbances, lewd or unlawful activities or noise either in the premises or involving patrons or the establishment in the immediate vicinity of the premises. The Commission will also impose restrictions on the license. Licensee is Midnite Sports Bar & Grill, LLC; David Dominguez, member.

Commissioners ratified the following stipulated settlements for permitting employee(s) to mix, sell, or serve alcoholic beverages, or supervise those who do, without a valid alcohol service permit:

**Ya Hala Lebanese Cuisine**, 8005-8009 SE Stark, Portland, will pay a \$1,485 civil penalty or serve a nine-day liquor license suspension. Licensee is Ya Hala, Inc., John Attar and Mirna Attar, corporate principals.

**Ira's Deli**, 7215 NE Prescott St., Portland, will pay a \$1,485 civil penalty or serve a nine-day liquor license suspension. Licensee is Shira's, Inc., Iraj Rafei, corporate principal.

**Pelinti Pizza**, 2910 W Cascade Ave., #102, Hood River, will pay a \$1,485 civil penalty or serve a nine-day liquor license suspension. Licensee is Hood River Pizza, LLC; Gabriel Head, member.
