## OLCC Commissioners Ratify Stipulated Settlements for Liquor Violations and 50-cent surcharge on Distilled Spirits

**PORTLAND, OR** – At its monthly meeting July 26, 2018, the Commissioners of the Oregon Liquor Control Commission heard the following contested case hearing and rendered decision.

**Sting Pub**, 7737 SE 82<sup>nd</sup> Ave., Portland, will have its full on-premises sales license cancelled due to a history of serious and persistent problems dating back to July 3, 2016. Licensee is Lucky Stars 82; Hui Liu, managing member.

Commissioners adopted the following staff recommendations:

Commissioners adopted staff recommendation for continuation of the 50-cent surcharge on distilled spirits (50-cents per bottle, 25-cents per mini). The surcharge is expected to generate \$37.9 million for the 2019-2021 biennium, with revenue distributed to the State General Fund. The current surcharge was scheduled to expire June 30, 2019, and was originally initiated in the 2009-2011 biennium.

Commissioners ratified the following fines and liquor license suspensions based on stipulated settlement:

**Gil's Speakeasy**, 609 ½ SE Taylor, Portland, will pay a \$1,485 civil penalty or serve a nine-day suspension. The licensee permitted disorderly activities on the property or in areas the licensee controls that are adjacent to or outside the premises, when an employee asked an unknown patron drinking at the premises to help him cut off and evict patron Humberto Piedra-Luis, which resulted in a physical assault with the unknown patron smashing a beer glass into Piedra-Luis's head. Licensee is Brett Gilhuly.

**Rodder's Grub and Pub**, 19195 S. Molalla Avenue, Oregon City, will pay a \$1,485 civil penalty or serve a nine-day suspension for an employee selling, giving or otherwise making available alcoholic liquor to a visibly intoxicated person. Licensee is Fire Dragon, Inc; Joe Zhou, member.

Commissioners ratified the following stipulated settlements for permitting employee(s) to mix, sell, or serve alcoholic beverages, or supervise those who do, without a valid alcohol service permit:

**Daddy Mojo's Cafe**, 1501 NE Fremont, Portland, will pay a \$2,145 civil penalty or serve a 13-day suspension. Licensee is Viwa International, Inc; Vilath Oudomphong and Noriko Satake, members.

**Eat: An Oyster Bar**, 3808 N Williams, Portland, will pay a \$1,485 civil penalty or serve a nine-day suspension. Licensee is EaT Group, Inc; Tobias Hogan and Ethan Powell, members.

**Beach Hut Deli**, 852 NW Brooks Street, Bend, will pay a \$1,155 civil penalty or serve a seven day suspension. Licensee is Beach Bend, LLC; Richard Taylor, member.

The Commissioners ratified the following stipulated settlements for failing to verify the age of a minor before allowing him/her to buy or be served an alcoholic beverage when he/she reasonably appeared to be under 26 years of age.

**Roseburg Tobacco and Food Mart**, 2050 NE Stephens St., Roseburg, will pay a \$1,485 civil penalty or serve a nine-day suspension. Licensee is Manjit Sandhu.

**Columbia Market**, 450 Wanapa, Cascade Locks, will pay a \$3,795 civil penalty or serve a 23-day suspension. Licensee is Red Star, Inc; Albert Choi, members.

Commissioners ratified the following stipulated settlements for license applicants:

**Barley Sprout**, 17100 NW Sauvie Island Road, Portland, as part of the Special Event Brewery Public House License for the premises, is not to allow Donald Kruger to be on the licensed premises during any licensed event occurring in 2018 and is not to allow Donald Kruger to take part in the operation or management of the business, or provide services to the business, as part of licensed events in 2018. Licensee is Lughnasadh Farms Malthouse and Brewery, LLC; Dylan Goldsmith, member.

**Outrage**, 424 SW Fourth Avenue, Portland, as part of the Full On-Premises Sales License for this premises, has the following restrictions: Sale and service of alcohol is prohibited between 1:30 and 7:00 a.m. Saturday and Sunday mornings, with patron possession on alcohol prohibited between 2:00 and 7:00 a.m.; A patron may possess no more than one container of alcohol at one time and each container of alcohol will contain no more than 156 ounces of malt beverage, 16 ounces of cider, 6 ounces of wine or 2 ounces of distilled spirits; Licensee will have at least one DPSST-certified staff member on premises on Friday and Saturday nights from 9:00 p.m. to the close of business. Licensee is Unsullied, LLC; Justin Green, Jeff Hotes and Lori Brown, members.

Commissioners ratified the following stipulated settlements for violations of the Oregon Bottle Bill by wilfully refusing to accept empty beverage and refusing to pay the customer the value of those containers:

**7-Eleven Store #2363-23007E**, 1621 SE Stark, Portland, will pay a \$660 civil penalty or serve a four-day suspension. This is a repeated violation. Licensee is Money 4 Nothing, LLC; Sohail Tanveer, president.

**Safeway Store #1951**, 8330 N Ivanhoe St., Portland, will pay a \$990 civil penalty or serve a six-day suspension. Licensee received a prior warning and this is a repeated violation. Licensee is Safeway, Inc.; Robert Miller, Robert Gordon, Bradley Fox, Robert Dimond, Howard Cohen and Albertson's Companies, LLC, officers and stockholders.

**Dollar General Store #18501**, 211 West B St., Rainier, will pay a \$660 civil penalty or serve a four-day suspension. This is a repeated violation. Licensee is DG Retail, LLC; DG Promotions, Inc., Larry Gatta and Jason Reiser, members.

**7-Eleven Store #2363-17959D**, 4250 NE 122<sup>nd</sup>, Portland, will pay a \$660 civil penalty or serve a four-day suspension. This is a repeated violation. Licensee is T&K Puls, Inc.; Thomas Puls and Karen Puls, officers.

**EL Porvenir Mini Market**, 25 SE 162<sup>nd</sup> Ave., Portland, will pay a \$660 civil penalty or serve a four-day suspension. Multiple customers were involved in the violation. Licensee is Federico Villalobos.
