## **OLCC Announces Pappy Van Winkle and the Buffalo Trace Distillery Antique Collection as Second Public Drawing for Rare and Limited Edition Liquor**

**Portland, OR** – The Oregon Liquor Control Commission is set to begin its second public drawing for rare and limited edition liquors, this time featuring the full lineup of Pappy Van Winkle and Buffalo Trace Distillery Antique Collection bourbons. Just in time for the holiday season, the public drawing will be launching Thanksgiving Day, and run 11 days, from Thursday, Nov. 22 until Sunday, Dec. 2.

In order to increase the odds of winning, multiple bottles of several of the 11 products will be available. For example, 24 bottles will be available for Pappy Van Winkle Family Reserve 10 Year, and 12 bottles will be available for Pappy Van Winkle Family Reserve 12 Year. Other products will be more limited, such as only six bottles of Thomas H. Handy Sazerac and a single bottle of each of Eagle Rare 17 Year and Van Winkle Family Reserve Rye will be available.

Entrants can sign up to win the chance to purchase just one bottle, or one of each of the products offered. Open to eligible Oregon residents only, those who win the opportunity to purchase will need to complete the transaction at any one of OLCC's 273 liquor stores around the state.

"This public drawing is the newest, most remarkable feature of an agency that's focused on providing Oregon customers a unique, world class selection of spirits," said Steve Marks, OLCC Director. "We had a great response to the first-ever public drawing last month and we are excited about our second public drawing featuring Pappy Van Winkle. We will again be giving Oregonians from every part of the state a chance to purchase these rare and limited editions liquors."

The first public drawing, which wrapped up Oct. 18, featured six bottles of the limited edition 2018 Old Forester Birthday Bourbon. A random drawing selection chose winners from 2,261 eligible entrants, with odds of winning 1:377.

OLCC receives special releases throughout the year, but there is a limit on quantities we receive from manufacturers and suppliers. The state has no control over how many bottles it receives each year. OLCC plans to use a public drawing to make available a portion of these rare or limited releases throughout each year.
