## OLCC Commissioners Ratify Stipulated Alcohol and Licensing Settlements and Hear Presentations

Also heard was a staff overview hemp and CBD in alcoholic beverages; product optimization; and a retail expansion update

**PORTLAND, OR.** – At its monthly meeting June 20, 2019, Commissioners ratified the following alcohol violation fines and suspensions based on stipulated settlement:

**Siam Sushi Restaurant**, 165 E Historic Columbia River Hwy, Troutdale, will pay a \$1,485 civil penalty or serve a 9-day suspension for licensee permitting its employees to mix, sell and serve alcoholic beverages, or supervise those who do, without a valid service permit. Licensee is Siam Sushi Restaurant, LLC; Chusi Navan, Managing Member.

**Logan's Market**, 900 SW 23<sup>rd</sup> St., Redmond, will serve a 21-day suspension for licensee's employee, agent or representative failing to verify the age of a minor before allowing her to buy or be served and alcoholic beverage when she reasonably appeared to be under 26 years of age. Licensee is How-Soel, Inc.; Logan Hamilton, President/Director/Stockholder; Greg Jarolimek, Vice President//Director/Stockholder; Pattie Hamilton, Secretary/Director/Stockholder.

**Caffe Allora**, 504 NW 9<sup>th</sup> Ave., Portland, will either pay a \$1,485 civil penalty or serve a 9-day suspension for licensee permitting their employee, agent, servant or representative to mix, sell or serve alcoholic beverages, or supervise those who do, without a valid service permit issued by the Commission. Licensee is Allora, LLC; Paolo Parrilli, Managing Member.

**Antoni's Restaurant Diner**, 10765 SW Canyon Rd., Beaverton, will either pay a \$1,815 civil penalty or serve an 11-day suspension for licensee permitting their Corporate Principal to mix, sell or serve alcoholic beverages, or supervise those who do, without a valid service permit issued by the Commission. Licensee is Antoni's, LLC; Anthony and Nicholas Tzakis, Members.

Commissioners ratified the following licensing stipulated settlements:

**Powellhurst Tavern**, 12344 SE Powell Blvd., Portland, will have its Full On-Premises Sales license issued with one restriction. Licensee is Fareast Food Corporation; Shu Yung Wu-Yuan, President/Treasurer/Director/Stockholder; Ko Chung Wu, Secretary/Director/Stockholder.

**Sauvie Island Beer Porch**, 17100A NW Sauvie Island Rd., Portland, will have its Full On-Premises Sales and Off-Premises Sales licenses issued with two restrictions. Licensee is OllieBelle, LLC; Debbie Lowder, Managing Member; John Stevens, Member.

Commissioners took final action on the following rules:

Amended OAR 845-005-0311 - The amendments clarify what constitutes an ownership interest in an alcohol license application and the circumstances when the Commission may waive an ownership interest. Effective July 1, 2019.

Amended OAR 845-005-0325 - The amendments codify the criteria that may support or overcome an alcohol license denial based on an applicant's conviction record. Effective Sept. 1, 2019.
