Michter's, Old Forester and Game of Thrones Featured for Next OLCC Public Drawing

Portland, OR – Your opportunity to pick up a bottle of Old Forester Birthday Bourbon is back for another year. Were you a fan of the HBO Game of Thrones? We've got the whole eight-bottle GoT whisky set too, along with Michter's Single Barrel Straight Rye Whiskey. These three products – 33 bottles total – are available in OLCC's latest chance to purchase drawing launching Wednesday!

The following items will be available:

- Old Forester Birthday Bourbon Whisky for \$99.95 (six entries selected)
- Michter's Single Barrel Straight Rye Whiskey for \$126.70 (three entries selected)
- Game of Thrones Single Malt Collection, eight bottle set, for \$407.60 (three entries selected)

The public drawing will be launching Wednesday, October 2 at 9:00 a.m., and run 7 days, until Tuesday, October 8 at 11:00 p.m.

Entrants can sign up to win the chance to purchase just one bottle, or one of each of the products offered, except for the Game of Thrones bottles which are being sold as a set of eight (three sets available). Open to eligible Oregon residents only, those who win the opportunity to purchase will need to complete the transaction at <u>any one of OLCC's 283 liquor stores</u> around the state.

This chance to purchase featuring Whiskey and Bourbon is OLCC's fifth public drawing, and marks the beginning of the second year of public drawings for rare and limited edition liquors for the agency. The first chance to purchase launched in October 2018 and featured six bottles of the limited edition 2018 Old Forester Birthday Bourbon.

OLCC receives special releases throughout the year, but there is a limit on quantities we receive from manufacturers and suppliers. The state has no control over how many bottles it receives each year. OLCC plans to continue to use a public drawing format to make available a portion of these rare or limited releases throughout each year.
