## OLCC Opens Sixth Public Drawing for Rare and Limited Edition Liquor

**Portland, OR** – Got holiday plans? This Thanksgiving, The Oregon Liquor Control Commission has one more thing for you to add to your list: Enter to win the chance to purchase some awesome rare and limited edition liquor in our sixth public drawing. A total of 125 bottles are up for grabs – including the 5-bottle Orphan Barrel Rhetoric Collection, valued at \$1,999.95 – to Oregonians across the state, now through December 3.

- **Old Rip Van Winkle 10 Yr** – 18 bottles – \$69.95
- **Pappy Van Winkle's Family Reserve 15 Yr** – Nine bottles – \$119.95
- **Pappy Van Winkle's Family Reserve 20 Yr** – Two bottles – \$199.95
- **Pappy Van Winkle's Family Reserve 23 Yr** – Two bottles – \$299.95
- **Sazerac Rye 18 Yr** - One bottle – \$99.95
- **Thomas H. Handy Sazerac Rye** – Six bottles – \$99.95
- **Van Winkle Special Reserve 12 Yr** – 18 bottles – \$79.95

The public drawing launched Wednesday, November 27 at 9:00 a.m., and will run 7 days, until Tuesday, December 3 at 11:00 p.m.

Entrants can sign up to win the chance to purchase just one bottle, or one of each of the products offered, except for the Orphan Barrel Rhetoric Collection bottles which are being sold as a set of five (two sets available).

Open to eligible Oregon residents only, those who win the opportunity to purchase will need to complete the transaction at [any one of OLCC's 283 liquor stores](#) around the state. Employees or representatives of the OLCC, or the spouse, child, brother, sister, or parent of any such employees or representatives are not eligible, including liquor agents and their employees.

This chance to purchase featuring Whiskey and Bourbon is OLCC's sixth public drawing, and marks the second year of public drawings for rare and limited edition liquors for the agency. The first chance to purchase launched in October 2018 and featured six bottles of the limited edition 2018 Old Forester Birthday Bourbon.

OLCC receives special releases throughout the year, but there is a limit on quantities we receive from manufacturers and suppliers. The state has no control over how many bottles it receives each year. OLCC plans to continue to use a public drawing format to make available a portion of these rare or limited releases throughout each year.
