Winners Selected for OLCC Sixth Public Drawing

Portland, OR – Last week’s Thanksgiving holiday might just be a fond memory for many, but for 123 lucky Oregonians, winning the opportunity to purchase a rare or limited edition bottle of their favorite spirit will help them keep the ‘thanks’ in Thanksgiving a bit longer. In one of the Oregon Liquor Control Commission’s largest public drawings yet, 125 bottles across 16 product families went up for grabs this past week. Over 9,000 eligible entrants vied for the opportunity to purchase one – or more – of the rare and limited edition bottles.

The drawing pulled Oregonians from around the state, with entries from Warrenton to Halfway, and from The Dalles to Ashland. In total, 230 different cities were represented with 123 unique winners from 39 Oregon cities gaining the sought after opportunity to purchase.

The odds of winning varied by product, but ranged from 1 in 946 for Pappy Van Winkle 15 Yr – one of the most popular items in the drawing with multiple bottles available – to 1 in 1,369 for the Orphan Barrel Rhetoric Collection, the most expensive item in the drawing with just two sets available.
