## OLCC seeks input on minimum pricing for distilled spirits

**Written comments may be submitted until March 15th, 2021, at 5 PM**

**Rule:** Per [OAR 845-015-0138](http://www.oregon.gov/OLCC/Pages/OAR-845-015-0138.aspx), the Commission shall consider any written or verbal comments before implementing such a price increase.

**Public Action:** The Commissioners of the Oregon Liquor Control Commission will accept written and verbal public comment on the proposed implementation of setting a minimum price. The proposal sets the price by proof and bottle (container) size using a consistent proof base value per container size. No distilled spirit bottle shall be sold for less than the established minimum price. The setting of minimum prices can contribute to decreased social harms and adverse health impacts.
