OLCC Status Definitions

License Active:	Approved applicant has <u>paid</u> license fee. OLCC has <u>issued</u> the license. Identified as "Active" in the licensing system.
Approved Not Paid:	OLCC has approved the application. Applicant has <u>not paid</u> the license fee. Identified as "Pending License Payment" in the licensing system.
Assigned:	Application is assigned to an investigator and is under OLCC review. Identified as "Assigned" in the licensing system.
Ready for Assignment:	Applicant has submitted a completed Land Use Compatibility Statement (LUCS) signed by the applicant's local government, and is awaiting assignment to an investigator. Identified as "Local Government Review" in the licensing system.
Without Approved LUCS:	Applicant has submitted an application but has not submitted a completed Land Use Compatibility Statement (LUCS) signed by the applicant's local government. Identified as "New" in the licensing system.

OLCC Status Definitions

License Cancelled:	The commission has made a decision to cancel the license due to compliance issues.
Serving Suspension:	The license is serving a suspension based on the findings of a compliance investigation.
Denied:	A completed license application has been submitted, and was determined to be unlicensable.
Expired:	The licensee elected to not renew the license.
Surrendered:	The Licensee has surrendered their license to OLCC and OLCC has accepted the surrender. Licensee has no authority to engage in licensed activities.
