On August 29, 2022, Licensee entered into an Interim Stipulated Order to voluntarily withdraw from practice and place her license in Inactive status pending the completion of the Board's investigation into her ability to safely and competently practice medicine.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain healthcare providers, including physicians, in the State of Oregon. Janet Marie Eoff, MD (Licensee) is a licensed physician in the State of Oregon.

2.

The Board received credible information regarding Licensee that resulted in the Board initiating an investigation. In order to address the Board's concerns while this matter is under investigation, Licensee and the Board agree to the entry of this Interim Stipulated Order, which is not an admission of any wrongdoing on the part of the Licensee. Licensee understands the terms of this Order and signs freely, without fraud or duress.

3.

While this matter is under investigation, Licensee agrees to the following conditions:

3.1 Licensee voluntarily withdraws from the practice of medicine and her license is placed in Inactive status pending the completion of the Board's investigation into her ability to safely and competently practice medicine.

3.2 Licensee understands that violating any term of this Order will be grounds for disciplinary action under ORS 677.190(17).

4.

At the conclusion of the Board's investigation, Licensee's status will be reviewed in an expeditious manner. Following that review, if the Board determines that Licensee shall not be

1 permitted to return to the practice of medicine, Licensee may request a hearing to contest that
2 decision.

3 5.

4 This Order is issued by the Board pursuant to ORS 677.265(1) and (2) for the purpose
5 of protecting the public, and making a complete investigation in order to fully inform itself with
6 respect to the performance or conduct of the Licensee and Licensee's ability to safely and
7 competently practice medicine. Pursuant to ORS 677.425, Board investigative materials are
8 confidential and shall not be subject to public disclosure. However, as a stipulation this Order is
9 a public document and is reportable to the National Practitioner Data Bank and the Federation of
10 State Medical Boards. This Order becomes effective the date it is signed by the Board's
11 Executive Director or Medical Director in accordance with OAR 847-001-0030.

On September 1, 2022, the Oregon Medical Board (Board) issued an order, immediately suspending the medical license of Sanjeev Kumar Sharma, MD (Licensee), pursuant to ORS 25.750 to 25.783.

Under ORS 183.411 and OAR 847-001-0035, the Executive Director of the Oregon Medical Board (Board) is authorized to issue orders reinstating licenses when the suspension occurs by operation of law pursuant to ORS 25.750 to 25.783, and the licensee would otherwise be in good standing, active status.

On September 2, 2022, the Board was properly notified that Licensee's medical license may be reinstated. Accordingly, pursuant to ORS 25.774, Licensee's medical license is hereby reinstated to active status.
