14	initiating an investigation. In order to address the Board's concerns while this matter is under
15	investigation, Licensee and the Board agree to the entry of this Interim Stipulated Order, which
16	is not an admission of any wrongdoing on the part of the Licensee. Licensee understands the
17	terms of this Order and signs freely, without fraud or duress.

19	While this matter is under investigation, Licensee agrees to the following conditions:
20	3.1 Licensee voluntarily withdraws from the practice of medicine and his license is
21	placed in Inactive status effective November 15, 2022, pending the completion of the Board's
22	investigation into his ability to safely and competently practice medicine.
23	3.2 Licensee understands that violating any term of this Order will be grounds for
24	disciplinary action under ORS 677.190(17).
25	3.3 Licensee must notify the Oregon Medical Board within 10 days as to how patients
26	may access or obtain their medical records.
