Statement of Need

The temporary rule is needed to increase the potential number of physicians and physician assistants who can care for patients in Oregon during a declared emergency. The temporary rule meets that need by reducing practice restrictions and providing a streamlined reactivation process for a qualified group of physicians and physician assistants during a declared emergency.

Justification

The Governor of Oregon declared a state of emergency due to the COVID-19 outbreak on March 8, 2020. The Governor's Executive Order No. 20-03 directs state agencies to develop and implement procedures, including adopting temporary rules within the agency's authority designed to prevent or alleviate the public health threat.

The Oregon Medical Board's temporary rule is needed to increase the potential number of physicians and physician assistants who can care for patients in Oregon during the declared emergency while continuing to uphold the Board's mission to protect the health, safety, and wellbeing of Oregon citizens. Failure to immediately amend the rule would prevent these physicians and physician assistants the ability to return to active practice in Oregon during the declared emergency. Oregonians seeking medical care would suffer these consequences. Acting now will give these physicians and physician assistants and the health care systems they work within the ability to onboard them now.

The temporary rule mitigates those consequences by providing a streamlined process for Administrative Medicine, Inactive, Lapsed, and Retired status licensees to reactivate to Active status. The temporary rule reduces practice restrictions for Locum Tenens and Emeritus status licensees during the declared emergency. The Oregon Medical Board finds that failure to act promptly will result in serious prejudice to the public interest by not immediately allowing these physicians and physician assistants the ability to expand or return to active practice in Oregon.

Statement of Need

Based upon the needs of the community and health care systems, the temporary rule is needed to provide flexibility in

the scope of practice for emergency medical services (EMS) providers during the period of the COVID-19 declared emergency. The temporary rule upholds the Oregon Medical Board's mission to protect the health, safety, and wellbeing of Oregon citizens by only allowing this flexibility under a supervising physician's standing orders and within the protocols established by the State of Oregon EMS Medical Director, subject to such limitations and conditions as the Governor or Oregon Medical Board may prescribe.

Justification

The Governor of Oregon declared a state of emergency due to the COVID-19 outbreak on March 8, 2020. The Governor's Executive Order No. 20-03 directs state agencies to develop and implement procedures, including adopting temporary rules within the agency's authority designed to prevent or alleviate the public health threat.

The Oregon Medical Board's temporary rule is needed to provide flexibility in the scope of practice for EMS providers during the COVID-19 declared emergency, subject to limits provided in the temporary rule. EMS providers are uniquely situated to provide medical assistance in the community. Failure to immediately adopt the rule would uphold the current limits on the scope of practice for EMS providers and not allow them to provide additional medical services during the COVID-19 declared emergency.

The temporary rule mitigates those consequences by providing flexibility in the EMS scope of practice during the declared emergency, subject to limits provided in the temporary rule. The Oregon Medical Board finds that failure to act promptly will result in serious prejudice to the public interest by not immediately allowing EMS providers to serve the community in a greater capacity during the COVID-19 declared emergency.

Statement of Need

The temporary rule is needed to clarify and assure that during a declared emergency all board licensees are expected, in connection with the practice of medicine, to fully comply with Executive Orders and statewide guidance implementing the Executive Orders when the Order or guidance documents in whole or in part address or affect the delivery of healthcare to Oregon patients.

Justification

The Governor of Oregon declared a state of emergency due to the public health threat of the COVID-19 pandemic. The Governor's Executive Order No. 20-03 directs state agencies to develop and implement procedures, including adopting temporary rules within the agency's authority designed to prevent or alleviate the public health threat.

The Oregon Medical Board's temporary rule is needed in response to the COVID-19 pandemic to support efforts to keep Oregon patients safe when accessing healthcare from Oregon Medical Board licensees during a declared emergency. The Board finds that failure to act promptly will result in serious prejudice to the public interest and could setback efforts to keep Oregonians safe during a declared emergency and adversely affect public health and safety. The temporary action clarifies and assures that during a declared emergency all board licensees are expected, in connection with the practice of medicine, to fully comply with Executive Orders and statewide guidance implementing the Executive Orders when the Order or guidance documents in whole or in part address or affect the delivery of healthcare to Oregon patients.
