**15 Approval of New Certificate of Removal Registration, with effective date: None**

*A Certificate of Removal Registration allows funeral directors employed by a licensed funeral establishment (FE) licensed in a contiguous state, for the limited purpose of removing dead human bodies from Oregon, prior to submitting a report of death. In order to qualify, an FE must be located in a neighboring state with removal laws substantially similar to Oregon's. Each branch of a registrant's FE is a separate establishment and must be registered as a fixed place of business. Once approved, registrations remain valid until surrender, change of ownership or Board action. (ORS 432.317(9); ORS 692.160(a); ORS 692.270)*
