In order to qualify, an FE must be located in a neighboring state with removal laws substantially similar to Oregon's. Each branch of a registrant's FE is a separate establishment and must be registered as a fixed place of business. ORS 432.317(9); ORS 692.160(a); ORS 692.270 (Once approved, registrations remain valid until surrender, change of ownership or Board action.)

- * **a** **Colin Allen's written request to the Board requesting a two year extension of his embalmer apprenticeship.**

Pursuant to Oregon Administrative Rules (OAR) chapter 830-011-0020(8) embalmer certificates will not be granted to any person for a period longer than 48 aggregate months. When an apprentice has completed his or her apprenticeship, he or she will no longer be licensed as an apprentice, but must qualify either as a licensed embalmer or licensed funeral service practitioner. (9) Notwithstanding (8), the Board may consider a request for extension of the apprenticeship period for reasonable and extenuating circumstances beyond the control of the trainee (apprentice).

- * **b** **Craig Collin's written request to the Board requesting approval to manage three funeral establishments.**

Pursuant to OAR 830-030-0000(13) Upon providing written notification to the board, a funeral service practitioner may be permitted to manage two funeral establishments or two immediate disposition companies, or one of each. A funeral service practitioner may be authorized by the Board to manage more than two funeral establishments or immediate disposition companies, or a combination of same, upon providing a written request to the Board that describes the basis for the request. The Board may approve the request after consideration of relevant facts or circumstances including, but not limited to, information that the Board may request from the funeral service practitioner.

- * **c** **Gary Trick's written request to the Board requesting approval to manage three funeral establishments.**

Pursuant to OAR 830-030-0000(13) Upon providing written notification to the board, a funeral service practitioner may be permitted to manage two funeral establishments or two immediate disposition companies, or one of each. A funeral service practitioner may be authorized by the Board to manage more than two funeral establishments or immediate disposition companies, or a combination of same, upon providing a written request to the Board that describes the basis for the request. The Board may approve the request after consideration of relevant facts or circumstances including, but not limited to, information that the Board may request from the funeral service practitioner.
