

# November 8 2018 General Session Meeting Minutes FINAL approved by Board Jan 8 2019 (Revised January 2 2019)

## I Call to Order

The General Session of the Mortuary and Cemetery Board (Board) was called to order via a telephone conference at 10:09 am, in Portland.

## **II** General Session

After roll call, President Woodward thanked everyone for their time and participation. The primary purpose of this telephone conference meeting is for the Board to consider information obtained as part of an investigation of licensee or applicant conduct during executive session.
