REVISED REQUEST FOR TRANSFER OF APPRENTICESHIP

We recently revised our Request for Transfer of Apprenticeship form. This form can be found on the OMCB website under Forms. The revisions include clearer language about transferring an apprenticeship to a new supervisor. Note that a Transfer of Apprenticeship is not valid until approved by OMCB. The effective date will be based on the date the completed Request for Transfer form and payment are received, and the eligibility of the supervisor has been confirmed by Board staff.

If an apprentice intends to change the licensee to whom they are apprenticed, the apprentice must immediately file a request for approval of the transfer with the Board and pay the required fee (\$25 for Apprentice Funeral Service Practitioner; \$25 for Apprentice Embalmer).

When an apprentice ceases to work under a specific licensee, the apprenticeship certificate becomes null and void. It is the responsibility of the supervising licensee to notify the Board's office of any termination in employment or supervision of the apprentice.



OFDA CONVENTION RECAP

ADMINISTRATIVE RULEMAKING UPDATE: AMENDED APPRENTICE EMBALMER/FUNERAL SERVICE PRACTITIONER REQUIREMENTS

The Oregon Mortuary & Cemetery Board (OMCB) completed administrative rulemaking that amended licensing requirements for Apprentice Embalmers and Apprentice Funeral Service Practitioners by amending sections of Oregon Administrative Rules, Chapter 830. The Notice of Proposed Rulemaking was published in the January Oregon Bulletin and went into effect in February 2025.

The requirements for apprentice embalmers have been updated to include at least 35 arterial embalmings under the supervision of a licensed embalmer. The definition of "supervision" has been updated to mean that each task shall be performed by an apprentice embalmer only after receiving direction from a licensed embalmer. Updates were also made to how apprentice embalmers should complete their log books and can be found in more detail in OAR 830-011-0020(2)(c).

The requirements for apprentice funeral service practitioners have been updated to include at least 25 arrangements that include tasks listed in OAR 830-030-0004 under the supervision of a licensed funeral service practitioner. "Arrangement" is defined as funeral services or final dispositions for at need persons, fully from the initial contact through the disposition of remains. The definition of "supervision" has been updated to mean that each arrangement shall be performed by an apprentice funeral service practitioner only after receiving direction from a licensed funeral service practitioner. Updates were also made to how apprentice funeral service practitioners should complete their log books and can be found in more detail in OAR 830-011-0020(3)(d).

The newly amended rule can be reviewed in full on the <u>Oregon Secretary of State website</u>.
