**DESCRIPTION OF DUTIES**

a. INTRODUCTION:

This position is located in an Aircraft Support Equipment Maintenance section. The position accomplishes inspections, maintenance, servicing and repair, corrosion control, and major overhaul / modification of assigned powered ground support equipment. It also includes preventive maintenance, servicing, adjusting, troubleshooting, repair, receipt, and dispatch of assigned equipment.

b. DUTIES AND RESPONSIBILITIES:

(1) Performs maintenance and repair on powered ground support equipment such as engine driven generator sets, heaters, air conditioners, power distribution systems and other similar or related equipment. Works on non-powered equipment such as trailers, fuel tanks etc.

(2) Performs all inspections, repairs, servicing and overhaul of components including engines, electrical systems, electronic panels, compressors, blowers, and all other components of the equipment.

(3) Uses layouts, drawings, wiring diagrams, schematics and technical orders. Accomplishes maintenance and repair procedures to correct recurring malfunctions. Uses test sets to determine proper operation of equipment, interprets findings and makes adjustments. Insures conformance with standards of safety and quality that provides exact electrical power tolerance necessary for ground maintenance of complex electronic systems. Performs required TCTO's/modifications of assigned equipment.

(4) Prepares for and participates in various types of readiness evaluations such as ORI, IG inspections and mobility and command support exercises.

(5) Performs other duties as assigned.

c. SUPERVISORY CONTROLS:

Work is performed under the general supervision of a higher graded Powered Support Systems Mechanic. Assignments are given in the form of work orders, inspection reports, or oral instructions. Plans work sequences, selects tools and repair parts, and otherwise carries assignments through to completion, referring only highly unusual and difficult problems to supervisor. Work is subject to spot check upon completion for acceptability and adherence to instructions and established standards. Guidelines available for reference include technical orders and manuals, manufactures specifications, factory engineering bulletins and standard operation procedures.

d. WORKING CONDITIONS:

Works inside and outside, in inclement weather, on icy, wet and slippery surfaces and work areas, and in temperature and humidity extremes. Subject to the dangers from exposure to toxic fumes, high pressure air and fluids, engine noise, heat blast, electrical voltage, lubricants, paints and solvents. Physical efforts involving climbing, stooping, standing, bending, stretching, and working in tiring and uncomfortable positions. Requires moderate to strenuous physical exertion including pushing and pulling of wheeled equipment. Lifts heavy equipment and components, weighing up to 90 pounds; and with assistance, lifts items weighing over 100 pounds.

e. QUALIFICATIONS:

- (1) Must have 12 months experience and/or appropriate training in functions such as inspection maintenance, repair and modification of powered ground support equipment used in support of electronic systems or sub-systems.
- (2) Must have experience and/or appropriate training which would demonstrate a thorough knowledge of principles of electrical, electronics, heating, refrigeration, pneumatics, hydraulics, internal combustion engines and small gas turbines as applies to Powered Ground Support Equipment, and use of applicable technical publications, blueprints, diagrams, material, and maintenance control procedures.

f. OTHER SIGNIFICANT FACTS:

- (1) Must have or be able to obtain a government license to operate vehicles up to 1 ton in the performance of duties.
- (2) Qualify for the appropriate security clearance required of the position.
