Introduction

Caseload Forecasting

- SB 337 (2023) required, for the first time, that a formal population forecast be created forecasting the populations of adults and juveniles eligible for appointed counsel. These requirements are contained in ORS 151.235.
 - The forecast is to be issued by the Department of Administrative Services (DAS).
 - OPDC is required to use it in preparing budget requests and for any other purposes determined necessary by the Commission.
 - Similar to other forecasts, DAS is required to issue population forecasts on April 15 and October 15 annually.

Basic Budget Development Timeline†

All actions on this slide occur each **even year** in advance of odd year Legislative Sessions.

Step 1: January


Agency begins high level Agency Request Budget Development (ARB), including initial policy option package ideas.

Step 3: June

Using feedback from CFO, agency refines its Agency Request Budget.

Step 5: December

The Governor's Request Budget is released in advance of Legislative Session (which begins the following month)..



Step 2: May/June

Agency submits its CSL budget, along with preliminary policy option packages (POPs) for CFO Review.

Step 4: August

Agency submits its final Agency Request Budget, along with approved policy option packages to CFO and the Governor.

- Currently, there is no monthly error reporting for the Public Defense Forecast.
- But, there are ongoing discussions (mainly related to data) so that these reports can be developed and distributed in the future.


This briefing paper looks at the performance of the prison population forecast for the October of odd years beginning with October 1999². For each forecast, we compare the projection for the July 1 population at the end of the respective biennia with the actual population that is realized when that day arrives. This error timeframe is called the inter-biennial error and is chosen due to the many legislative changes that have occurred over the past two decades, including Ballot Measure 57 (2008), House Bill 3508 (2009), Senate Bill 1007 (2010), Ballot Measure 73 (2010), Senate Bill 395 (2011), House Bill 3194 (2013), and HB 3078 (2017). Comparing a forecast made prior to one of these changes to an actual population post hoc produces an over estimate of the baseline methodology's performance error.

As presented in the above table, the average error over the observed timeframe was five more actual beds than forecast. In percentage terms, this error is statistically indistinguishable from zero and is evidence that the methodology in use exhibits no bias to either a higher or lower extent. If we look at the deviation in the errors in percentage terms and multiply by two, we get a historical 95-percent confidence interval of 2.1 percent. This can be used as a proxy for the expected deviation for future October of odd year forecasts such as that which will be released October 1st, 2019. This report will be published following the end of each biennium going forward.







The Oregon Public Defense Caseload forecast projects instances of new eligibility for public defense counsel. In addition, open caseloads have been added as of the April 2025 forecast. The forecast is delineated by several categories: adult vs. juvenile; thirteen case types (felony, misdemeanor, civil commitment, dependency, etc.); circuit vs. appeliate; county. Monthly counts are available out to the 2029-31 biennium. The county level detail is further disaggregated for adult felony by Jessica's Law, Murder, Measure 11, Major Felony and Minor Felony. Finally, historical lengths of eligibility episodes are available. The report and associated tables are scheduled to be issued twice a year, on April 15 and October 15.



What are the challenges?

- Because the public defense caseload forecast is new, there are still data concerns that must be addressed.
 - This impacts the forecast itself, and
 - It also impacts tracking between forecasts.
- The timing of the forecast can be an issue in integrating the results into other business of OPDC beyond the budget build.
 - It is likely that OPDC will not be able to rely on the forecast exclusively when responding to local needs.



Unrepresented Statewide Trends

Down 26% Year Over Year

Unrepresented numbers are down 26% from December 1, 2024.



Down 33% From Peak

Currently, there are over 2,700 unrepresented individuals, a 33% reduction since the peak in February 2025 of over 4,100 unrepresented.




Downward Trend Continues

The downward trend we've seen over the past 6 months has continued with the start of the 25-27 contracts in October.

Coos County







Unrepresented Nearly Eliminated

As of Nov. 28, 2025, Coos County reported two out-of-custody and zero in-custody unrepresented individuals.



Oregon Trial Division and ERD

OPDC stationed one OTD attorney in Coos, and they established an Early Resolution Docket (ERD), which helped eliminate the backlog. OTD has taken over 150 cases in the past year.




New Provider Added

OPDC has added a second contract provider to Coos for the 25-27 contract.

Douglas County







Mixed Progress

Douglas County numbers fluctuate significantly, though there was a sharp decline with the start of the new contracts.



New Capacity Added

OPDC has added 1.15 MAC to the Douglas County 25-27 contracts. OTD also provides additional capacity whenever possible having taken 85 cases in the past year.




Unique Case Assignments

Douglas County has a unique process for assigning cases, rather than assigning cases at arraignment, all cases are put on the unrepresented list and removed by providers.

Jackson County







46% Reduction Year Over Year Jackson County numbers are down 46% compared to December 1, 2024, with outof-custody individuals decreasing 28% since the start of the new contracts.



Oregon Trial Division and EDP

OTD staffs a monthly Early Disposition Program, resulting in the resolution of 160 cases since May 2025. In total OTD has taken over 850 cases in the past year.




Enhanced MAC Program

Five Jackson County attorneys are participating in the Enhanced MAC program.

Marion County







73% Reduction Year Over Year

Marion County numbers are under 220 total unrepresented persons, which is down 73% compared to Dec 1, 2024.



Court Processes and Providers

Reductions have been driven by improved coordination between providers and court led efforts to assign cases at arraignment via "attorney of the day" model.




Oregon Trial Division and ERD

OTD provides additional capacity, having taken over 540 cases in the past year, which reduces the need for courts to preserve MAC. OTD has also staffed a new early resolution docket since October 2025.

Multnomah County







34% Decrease in Past 2 Months

Multnomah County has experienced a 34% reduction in the number of incustody individuals since the start of the new contracts after seeing a steady increase in September 2025.



Early Resolution Docket

After a successful pilot in August, OPDC is working with the DA to establish a consistent ERD.




Increased Provider Capacity

The 25-27 contracts increased provider MAC, including 3 Enhanced MAC participants. with newly licensed lawyers joining in December 2025.

Washington County







43% Decrease in Past 6 Months

Washington County numbers peaked at 738 individuals in May 2025 and have decreased by 43% since then. In-custody individuals have decreased by 76% since the start of new contracts.




Increased Provider Capacity

The 25-27 contracts increased provider MAC, including 4 Enhanced MAC, with newly licensed lawyers joining in December 2025.

OTD has removed 2,471 cases from the unrepresented list, including 622 Betschart cases. The charts show the location and case types taken.



Early Resolution Docket

OTD has partnered with district attorneys and courts in Multnomah, Marion, Coos, and Jackson counties to pilot or create early resolution dockets (ERD) for defendants with low-level charges.



104% MAC


OTD follows the MAC standard, calculated in the same manner as contractor MAC. Combined, the division is at 103.6% MAC utilization as of 11/28/25.

Unrepresented Case Entries & Exits



The number of cases exiting the unrepresented list surpassed the number of cases entering between March and August.

As a result of the 25-27 contracts starting, October and November saw a larger number of cases exiting the list compared to other months.





OPDC 12-Month Unrepresented Crisis Plan




