




### <u>Unrepresented Population Statewide Trends (8/1/22 – 4/11/25)</u>




### Jackson County Unrepresented Population Trends (4/1/24 - 4/11/25)

Decrease in the in-custody and out of custody pretrial unrepresented groups in the past year in Jackson County.




#### **Jackson County 5/29/24 - 4/11/25**







## **Updates**

# New requirements under the Qualifications for All Public Defense Attorneys Section:

- Rules of Professional Conduct added language that all attorneys providing legal representation agree to maintain client files for a period of no less than ten years, unless required by the Oregon State Bar to maintain the client files for a longer period of time.
- Accessibility NEW! Added requirements for accessibility and proximity to clients.

## **Updates**

# Qualification Standards for Representation in Criminal Proceedings, Criminal Attorney 1

 Allowing completion of a clinical term at an Oregon law school to meet Criminal Attorney 1 and Delinquency Attorney 1 standards as an approved pathway to qualification if the candidate proves a letter of support from the clinical supervisor.

# Qualification Standards for Representation in Delinquency Proceedings, Delinquency Attorney 1.

 Minimum Qualifications (Section 3., c., i.) - Added additional requirement language to include a presentation of a letter from immediate supervisor certifying the person's ability to represent clients in misdemeanor level or delinquency cases.






#### **Contract Award, Negotiations, and Execution:**



- Prior to joining us, he served with the U.S. Department of Veterans Affairs (VA) in the Office of Accountability and Whistleblower Protection (OAWP).
- Before his tenure at OAWP, Steve worked for the Department of Defense Office of the Inspector General (DoD OIG) in Administrative Investigations.





## Cases Per County Since January 2024 612 Cases Total








While there are many victories accomplished, here are some highlights:
