## Become a Juvenile Defense Trainer

Oregon's Office of Public Defense (OPDS) seek 5 attorneys for certification as elite trainers in juvenile defense.

The Juvenile Training Immersion Program (JTIP) is a highly specialized, comprehensive, 42-lesson trial advocacy program designed to enhance the capacity of juvenile defense attorneys across the country. JTIP is the gold standard in training for juvenile defenders and reflects a core commitment to the unique role and critical importance of specialized defense counsel in juvenile courts.

JTIP Trainer Certification is a 3-day intensive train-the-trainer program. The course centers on adult learning theory, maximizing dynamic facilitation and presentation skills, building techniques for providing skills-based feedback, and a comprehensive introduction to JTIP and the JTIP training methods. By attending this course you will become part of an elite corps of Certified JTIP trainers across the nation.

A JTIP Trainer Certification course is scheduled for July 16 – 18, 2020 in Portland, Oregon. The course will be hosted by Lewis & Clark Law School's Criminal Justice Reform Clinic and take place on the law school campus.

Those applicants selected to participate in the training commit to the following:

- **Attend the entire three-day trainer and certification course, scheduled for July 16 – 18, 2020, and**
- **Develop and deliver a JTIP-based training *at least one (1) time per year* over the course of three (3) years in their home region (or an assigned region) of Oregon.**
