<b>ACQC</b>	The client is acquitted of all counts in the charging instrument as a result of a bench trial
<b>ACQJ</b>	The client is acquitted of all counts in the charging instrument as a result of a jury trial
<b>CLCC</b>	The client is acquitted of the most serious count in the charging instrument but convicted of at least one other count as a result of a bench trial
<b>CLCJ</b>	The client is acquitted of the most serious count in the charging instrument but convicted of at least one other count as a result of a jury trial
<b>CNCV</b>	The client is convicted of the most serious count in the charging instrument as a result of a bench trial
<b>CNVJ</b>	The client is convicted of the most serious count in the charging instrument as a result of a trial
<b>COM</b>	The client is committed to the custody of OHA as a result of a civil commitment proceeding
<b>CONS</b>	The client enters a consolidated plea
<b>CONT</b>	The client is continued on probation after a probation violation hearing
<b>DENY</b>	The petition or application for writ is denied
<b>DIVR</b>	The client enters into Diversion or a Conditional Discharge agreement; use of this code does not terminate Counsel's obligation to report.
<b>DSCC</b>	The case is dismissed due to a completed civil compromise
<b>DSM</b>	The case is dismissed for reasons not otherwise specified
<b>EXTR</b>	The client is extradited after a hearing
<b>GRNT</b>	The petition or application for writ is granted
<b>INSA</b>	The client is found Guilty but Insane
<b>OTHR</b>	The case is disposed for reasons not otherwise specified*
<b>OTPA</b>	Other Post-Adjudicative, Post-Commitment, or Post-Conditional Release*
<b>PLGY</b>	The client entered a plea of guilty or no contest to the most serious offense on the charging instrument
<b>PLLC</b>	The court dismissed the most serious offense on the charging instrument in return for entry of a plea of guilty or no contest to a less serious charge
<b>RCOM</b>	The client was recommitted to the OHA
<b>REVK</b>	The client was revoked from probation after a probation violation hearing
<b>WAIV</b>	The client waived hearing on extradition
<b>WTBN</b>	The client has been on a bench warrant for 180 days
<b>WTHD</b>	The Counsel assigned to the case has withdrawn
