### Bikeway Description

300 words or less

Aufderheide Drive (Forest Service Road 19) connects Highways 126 (McKenzie River) and 58 (Oakridge), winding through the lush overgrowth of the majestic Willamette National Forest and meandering along the cold, clear waters of the McKenzie and Willamette Rivers. With minimal traffic and little to no man-made features, no other route immerses riders in nature quite like the Aufderheide.

The Aufderheide is already designated as a National Scenic Byway and Scenic Waterway, recognized for its spectacular views of mountains, lakes, creeks, and rivers. Shortly into the ride from the McKenzie side, is the Cougar Reservoir and Terwilliger (Cougar) Hot Springs.

Deeper into the route, riders will find old-growth forests, mountain meadows, abundant wildlife, full of osprey, deer, elk, bear, foxes, trout, salmon, and steelhead. For cyclists with an extra enthusiasm to wander the outdoors, the Aufderheide has over 5 campgrounds and 25+ trailheads along its 60-mile stretch, giving users an endless array of places to explore.

The road connects Oakridge / Westfir with the McKenzie River communities, both renowned for their mountain biking and water recreation, respectively. The route's starting points are adjacent to each town's iconic covered bridge, Oakridge's Office Bridge and the Belknap Covered Bridge. Both points are easily identifiable and accessible for visitors and residents alike. They each have bike-friendly lodges and restaurants, with designated parking, restrooms, and public access to water. Wayfinding is also a breeze, as the route simply has users stay on NF-19 without any confusing intersections or turns.

This can include safety and wayfinding signage, kiosk and informative signage, as well as other infrastructure improvements.

Congratulations! I am happy to report the State Scenic Bikeways Committee has recommended the Aufderheide route for designation as a State Scenic Bikeway.

Achieving this step in the process is a major landmark. Of the thousands of miles the bikeway committee has rated, less than half has been recommended for designation.

The next steps are for the proponent group to develop a bikeway plan, public meetings and finally, the Parks Commission to hold a formal vote on designation. All of this could easily take one year or more.

Dave: Joined board of Friend of historic Columbia River hwy. Jeanette is recovering from cancer and is getting better. Dave's plan is to develop a strategic plan instead of being hit and miss.

**Updates:** letter of road jurisdictions after committee votes to recommend so they are in full understanding and approval of the sign location table. Alex will draft copy and have someone on the county help craft it.

Any questions about who should be contacted in ODOT talk to Sheila

IGAs will now include a note that designation can be removed if there serious road condition gets much worse.

How do you measure road conditions on bikeway? Is there a Process to remove designation. Answer: yes- can measure if the rating changes. The ideal is that the threat of removal would be enough to motivate jurisdiction to fix

Travel Oregon: Cascading Rivers Workshop Feb. 25<sup>th</sup>. Will have call this week with proponent group for planning workshop. First item is to work on developing more core proponents to help plan.

Bicycle Tourism Studios: Nov. South Coast Bandon to border, Gresham chamber- Troutdale, Gresham, Corbett area working with Scott Bricker.

Wrapping up videos of "Powered by Travel" with one video on bicycle travel

Brainstorming ideas of networking events on the Willamette Valley Bikeway to get people engaged.

Did some filming on Old West using remote control helicopter camera.

ODOT updates- Sheila: used to be a number of grants that could fund bike projects. That is all now being folded into STIP Transportation Improvement Plan is ODOTs capital improvement program and it gets funneled into 1) maintenance (fix it) 2) Enhance which deals with adding, expanding sidewalks, roads. Safe routes to school, TE got folded into Capitol program now is vetted through ACTs- made up of local elected officials and recently added modal reps (transit, bike, ped) ACTs decide which ones to support and put on 150% list. Super ACT which of the 150% list will be funded. Look at Enhance program on website for more info. Go to Gov Delivery to sign up for notifications of what is happening.

Bulk of money that comes to ODOT (fed gas tax, state money) fed money is the majority of the money.

All money goes to Fix-it or Enhance. There is a third pot that was designated by the state legislature.

Fed pot comes with lots of strings, state pot must only be spent on roads open to motor vehicle traffic. This leaves a few activities out in the cold without a funding source so the legislature created Connect Oregon to fund the projects that do not qualify for the other pots. Connect Oregon added bike and ped

projects outside of roadway. Only 40 million in this pot for all projects that apply. Deadline is mid Nov. renewed by every legislative session. OBPAC money is state dollars so easier to apply and be awarded.

Gas tax has not kept up with inflation but expenditures are going up so some income tax revenue is going into hwy trust fund. In 2015 the current fed funding package expires and if there are not new revenue Oregon will get 30% less than what we have now. All the interest in alt modes is because of this so this makes us look at doing things better.

#### **Russ and Laura: Perspective on Bikeways**

- Creating short marketing videos, look at route from marketing perspective. What are the unique characteristics of each route.
- We did a great job in picking a lot of the routes.
- Videos need to explain flavor of each route Grande Tour stood out.
- Twin Bridges depends on clear day which they get most of time
- Found everyone fairly supportive that they contacted- tourism and businesses including finding additional businesses that are interested.
- Could tell the different between bikeway visitors and Trans Am riders. Bikeway had a vacation hang out mentality and spent more money.
- Tualatin hardest to film: Called several of us to find out what is about route that is unique. Part of issue was they had just filmed Willamette so they can encourage people to do both. Surprised by amount of traffic and got buzzed by cars on road portion between Hillsboro and Forest Grove. North of Forest Grove almost no traffic. Near the golf course the worst. Sheila: As cycle numbers grow motorist behavior improves. Positive feedback loop that can be started by telling motorists that cyclists add to the economy.
- More fun if it was a loop instead of an out and back. McKenzie pass riding from Sisters over gives you a 20 mile climb.
- Willamette Valley point to point is easier because of Amtrak.
- Blue Mt Most challenging physically because of lack of services and no water. Had sag support from Heppner Chamber. 90 degrees when they were there.
- Leave guest books to get feedback and get rough numbers.
- Hand out diaries then when handed in they get a something
- Old West still one of our favorites diverse and first one we rode
- Appreciated the ways you can split up the Grande Tour – long day, short day, things to do. Grande tour was old west light = more accommodations and food
- Make sure the one bikeway is different enough from each other. Someone could go do all of them so they have different experiences on each one.
- Was experience based on landscape or level of services? Answer: First thing you notice is the scenery. Then you get deeper into towns and activities. Three in eastern OR are each very different. Central OR ones are all the same landscape. People remember the small towns and friendly people

- Pavement quality: Mile long stretch coming into Baker City excited to see unpaved section because they want a unpaved route as a bikeway.
- Need to get up surveys maybe with incentive to fill out.

#### **Committee Structure at OPRD:**

- Many committees are to serve as long as Governor/Director sees fit.
- Often staff is not a member of the committee.
- Many of the committees, including this one designates things by use of criteria

Heritage Commission has nine people appointed by Governor

Some committees are appointed by OPRD director

- Director responsible for structure and operations. Director is ultimately responsible
- Heritage commission members serve at pleasure of the governor.
- Not all committee decisions are not carried as it moves up the chain of command. This is there as a check and balance in case the recommendation might run counter to. You can come with decision that is not carried forward as it moves up chain up of command. Typically there as a check and balance. The recommendation might run counter to other policies or politics. For example: Commission voted to for designation in the historic register. Roger did not think approval met standards. Roger could not support the commission's recommendation. He forwarded committee's approval and his reasons for not supporting. The Parks Service decided to support OPRDs recommendation.
- OPRD tries to provide training you need to be successful so that you understand Statute and Administrative Rules (OAR) Statute is general, OAR fills in gaps, and Procedures is at staff level- basic workings how it works. Committee has role in shaping the procedure and puts in the important details. Statute must be made at the legislature, OAR is written through a public process handled by

staff and voted on by the Parks Commission. If you do not like something we can look at why it is that way and maybe we change it. OPRD can change rules, but do not like to open up statutes.

- Statute creating ORTAC was written the 1970s. This is the statute that allowed the Bikeway committee to exist. **ORTAC job is to look to make sure our process is sound.** Bikeway committee is a subcommittee of ORTAC, this is the way the statute is written. ORTAC is in statute. The Bikeway committee is not.

Rocky: ORTAC might be able to delegate the authority of the bikeway committee, will need to ask OPRD attorney.

Roger Nyquist: I think that this committee is performing in an outstanding manner. If it is not broke don't fix it. For expediency keeping it the way it is the easiest way to go. If you think your recommendations are being carried forward than it is working. Have to consider the performance of the group in its entire work and not take a few miles of road as a problem.

Bonnie: We have seen it work the other way on Byways. The committee did not recommend, where the agency because of politics moved ahead with the designation.

**Relationship between Committee and Staff:** Staff contributes to discussion and can pass on staff recommendation which is different than the committee. If staff recommendation is different from Committee both should go forward to the next decision point. When in the field rating criteria staff is part of the rating team. This is different than when the full committee votes on it.

Committee won't be able to do all the needed reviews in one year-

- Invite proponents to join us
- Start to prepare for the five year review

Alex: most sections in very good shape, some sections graveled which people will hit going 30 miles per hour downhill on the best of the best bike riding in Oregon. I will get complaints about this.

There are also intermittent road closures during the height of the riding season. These factors will degrade the overall brand of the bikeway. You do not want people caught by surprise on these routes.

## Remembering Portland Chef Naomi Pomeroy

Last week, Oregon lost a legend in the culinary world.

Award-winning chef and entrepreneur Naomi Pomeroy was an unapologetic ambassador for Portland and Oregon in national food and wine media, helping to shape it into the scrappy, community-minded haven it is today. She was an unrelenting activist for local restaurants during the pandemic, when the entire industry went topsy-turvy.



Pomeroy, a native Oregonian, stood at the highest echelon of Oregon makers, embodying the spirit of the state's culinary bounty with her celebrated establishments including Beast, Expatriate, Ripe Cooperative and most recently Cornet Custard ice cream shop in Southeast Portland. She also had another restaurant and a summer communal dining experience in the works, serving veggies from her garden.

"If I weren't a chef, I would be a florist or a botanist," Pomeroy said in a 2014 Q&A with Travel Oregon. "I think that food and plants are very relatable."

The state and industry mourn her loss, as a titan of local food and community.



## Coos Bay: An Oregon Heritage All-Star Community

This week, the City of Coos Bay earned the title of Oregon Heritage All-Star Community, a designation created by the state's historic preservation office to recognize significant history and heritage efforts across the state. Coos Bay joins a short list of other Oregon cities that have won the right to claim the name (along with the recognition, logo, signage, workshops, and other resources that come with it), including Albany, Astoria, Bend, Cottage Grove, Oregon City, Roseburg and Salem.

We spoke with Heather Christenbury, the Executive Director, Curator & Collections Manager of Coos History Museum, about what the designation means for the city, the impact of heritage tourism on the local economy and the many partners who collaborated to make Coos Bay an Oregon Heritage All-Star Community.

If designated, this will be Lane County's 4th Scenic Bikeway – our latest addition since the local [Covered Bridges Scenic Bikeway](#), designated back in 2011.

Every September, hundreds of organizations come together to promote color accessibility and inclusion for the one in 12 men (8%) and one in 200 women (.5%) who are color blind; an estimated 13 million in the United States; 30 million in Europe; and 350 million worldwide.

**MINUTES**

**CALL TO ORDER / PLEDGE OF ALLEGIANCE:**

Mayor D'Lynn Williams called the meeting to order at 5:30 p.m. Councilors Kelly Packard, Katherine Bishop and Deretta Huey were present in person, as were City Recorder Nicole Tritten and Relief City Recorder Jessica Snyder. Councilor Edward Johnstone was absent at the start of the meeting. City Operator Bobby Archer was present via video. Those present in person stood and recited the Pledge of Allegiance.

**MAYOR'S MINUTE:**

Mayor Williams announced that it was the start of a new fiscal year for the City.

**STATE HOUSE CANDIDATE INTRODUCTION (NOT ON AGENDA):**

The Mayor invited Darin Harbick, present in person, to address the Council. Mr. Harbick introduced himself as the Republican candidate for House District 12. He stated that he was attending Council meetings around the District. He noted that he was on the Lane County Tourism Board and was working on the Scenic Bikeway project with Connor Nolan. The Council members and City staff introduced themselves to Mr. Harbick.

**CITIZEN COMMENTS ON AGENDA ITEMS:**

There were no citizen comments.

**COUNCILOR COMMENTS ON AGENDA ITEMS:**

There were no Councilor comments.

*Councilor Edward Johnstone joined the meeting via video at 5:33 p.m.*

**OREGON SCENIC BIKEWAY PROJECT – AUFDERHEIDE DRIVE:**

Connor Nolan, present via video, introduced himself as the Destination Development Manager at Travel Lane County. Mr. Nolan gave a visual presentation about the project to designate Aufderheide Drive (Forest Service Road 19) an Oregon Scenic Bikeway. He stated that Travel Lane County's main responsibility is to promote Lane County as a travel destination and grow visitor demand and overnight stays. He described the Oregon Scenic Bikeway program as being managed by three organizations: Travel Oregon, Oregon State Parks and Cycle Oregon. The program, founded in 2009, has the goal to designate the top cycling routes throughout the state, primarily in rural, scenic landscapes. He stated that an economic study conducted five years after the program launched determined that a cyclist traveling to a Scenic Bikeway spends \$693 on average per overnight trip. He noted that amount was almost three times what a typical visitor would spend.

Mr. Nolan briefly explained the administrative process to get the designation, thanking Westfir for the letter of support it provided. In the presentation, he showed content on the Travel Lane County website and described plans to add more road cycling content related to Scenic Bikeways. Mr. Nolan displayed proposed signage designs for the Aufderheide Bikeway. He stated that the capstone goal was to host a celebration kickoff event at the beginning of the 2025 cycle season to officially announce the

designation of the Aufderheide as a Scenic Bikeway. Mr. Nolan answered questions from the Council and City staff after his presentation, in particular about safety issues for riders.

**OAKRIDGE FIRE DEPARTMENT REPORT:**

Chief Scott Hollett was not present. There was no report.

**PORTAL PARK SECURITY CAMERAS PROPOSAL:**

At a special meeting on June 21 the Council had discussed two proposals to install new security cameras at Portal Park. The Council had decided on the Knox Contracting proposal but had not voted, pending review of the contract by the City Recorder.

Councilor Johnstone made a motion to approve the proposal from Knox Contracting to install new security cameras at Portal Park at a cost of \$6,632. Councilor Packard seconded, and the motion carried, 5–0.

**PORTAL PARK ELECTRIC WORK PROPOSAL:**

Mayor Williams made a motion to approve the proposal from GMD Electric to install power to the storage shed at Portal Park and to install a heater in the mechanical room at a cost of \$3,630. Councilor Johnstone seconded, and the motion carried, 5–0.

**SEPTEMBER 2024 COUNCIL MEETING DATE CHANGE:**

City Recorder Nicole Tritten requested that the September Council meeting be moved from the scheduled date of Monday, September 9, to Tuesday, September 3, to accommodate her vacation days. The Council agreed to the change. The Mayor said the new date would be posted on the City website.

**ESTIMATE TO AMEND LAND DEVELOPMENT CODE:**

The Council reviewed a proposal from Lane Council of Governments to make several amendments to the Westfir Land Development Code (LDC): Adopt standards for a Public Facilities zone; permit Manufactured Dwelling Parks (MDP) in the Community Residential Zone; remove the number of dogs permitted on a property in favor of regulation by the City animal ordinance; and remove pet kennels as an allowed use in all zones. The Public Facilities section was recommended by LCOG. The other amendments were at the request of the City Council. The Council is not able to adopt the Housing Needs Analysis completed by Cascadia Partners in June 2023 until MDPs are permitted in the Westfir LDC, per State law.

Councilor Packard made a motion to approve the proposal from Lane Council of Governments to amend the Westfir LDC at a cost of \$1,350–\$1,750. Councilor Huey seconded, and the motion carried, 5–0.

**AYES:** Williams, Packard, Bishop, Huey, Johnstone    **NAYS:** 0    **ABSTENTIONS:** 0

**MAYOR'S ROUNDUP:**

Mayor Williams gave the report and addressed these items:

- Westfir resident and physical education teacher, Amber Meske, and her husband, former Mayor Matt Meske, were hosting coordinated playtime for kids on Sunday evenings at Hemlock Park.

- Boat Launch/Confluence Park update: The heritage survey found no historical artifacts that would prevent developing the park, but the City had not yet received the written report; the City posted a “no camping” sign on the park gate; the Middle Fork Willamette Watershed Council (WWC) was hosting a Stewardship Day on August 9 to pull invasive plants and water new plantings; the WWC is researching kiosk signage content for the park; and the Mayor asked WWC to check with their indigenous tribal contact about whether the City could use the name *Turtle Island*. The WWC and the Mayor are working on the park management plan, which should be available for review by September 2024. Funding is needed for the upland parking and restrooms and trail consolidation.
- Councilor Packard made a copy of the Hazeldell Fire Station design plans as a reference for a Westfir fire station.

**WATER/SEWER REPORT:**

City Operator Bobby Archer presented the report. There were no problems at either plant. He reported that the new Relief City Operator was progressing well in his training. Nicole mentioned that the annual photo points of the river were required for the TMDL plan. Councilor Packard asked about the need to clear brush on the access road to the water tank.

**APPROVE MINUTES:**

Mayor Williams made a motion to approve the Council meeting minutes for June 3, 2024, and June 21, 2024. Councilor Packard seconded, and the motion carried, 5–0.

**CITY RECORDER REPORT:**

Nicole Tritten presented the report and addressed these items:

- DEQ Loan for a Wastewater Facilities Plan (WWFP): She reported that she reviewed the loan agreement from the DEQ for a \$100,000 forgivable loan for a WWFP. She stated that she had questions that she wanted addressed by DEQ before signing the agreement. [Mayor Williams had also read the agreement and didn’t have any major concerns. The Council agreed to a delay in signing the agreement until DEQ responded to Nicole’s questions.]
- Water Management and Conservation Plan (WMCP): Nicole reported that she had sent daily production data for 2019–2023 to GSI Water Solutions (GWS), and she was following up their questions. She stated that GWS was finding water loss on the order of 33–45% annually. The last WMCP estimated annual water loss at around 29%.

In addition, Nicole reported that there were benchmarks set in the last WMCP that the City hadn’t met, such as installing water meters on all City facilities, annual water audits, and public education about water conservation. She stated that Bobby was looking into the cost to add water meters at Hemlock Park, the wastewater plant and City Hall. The Mayor said the meters may not have been installed due to lack of funding. A meter had been installed at Portal Park since the last WMCP, but there were ample funds for the expenditure in the Highway Fund.

**CITY FINANCIAL REVIEW:**

Nicole Tritten submitted the cash deposits, bank statement, bank reconciliation, profit & loss report, and expenditure sheet; and she addressed these items:

- Westfir fire engine repairs: The repairs and pump test were completed at a cost of \$2,178.97.
- The fiscal year budget for 2024–2025: Nicole reported that she submitted the annual Department of Administrative Services survey, which is required in order for the City to receive State disbursements, and which is due by July 31. She stated that she emailed the two budget resolutions and Form LB-50, due by July 15, to the Lane County Tax Assessor.

**JULY EXPENDITURES:**

Mayor Williams made a motion to approve expenditures for July 2024 in the amount of \$84,122.33. Councilor Bishop seconded, and the motion carried, 5–0.





The Oregon Transportation Plan (OTP) outlines six key goals, with one of the most critical being Economic and Community Vitality.
