ACTION: Commissioner Berger moved to approve the proposed amendment to OAR 736-024-0025 to prohibit vehicles on the ocean shore in Lincoln City at NW 35th/34th Court year-round and NW 15th Street from May 1 to September 30 or when safety conditions warrant. Additionally, direct the agency to increase signage and communication regarding locations of accessible beach access points as presented by staff. Commissioner Grasty seconded. Motion passed, 5-0. (Topic starts at 03:58:51 and ends at 04:13:49)

c) Request to open- OAR 736-010-0020 and 736-021-0040- Amending Park exclusion rules (Action)

ACTION: Commissioner Deur moved to approve opening rulemaking to amend OAR 736-010-0015, 736-010-0020, 736-021-0030, 736-021-0040 to update the exclusion rule and appeal process in the park area and ocean shore state recreation rules as presented by staff.
