Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

SCENIC WATERWAYS NOTIFICATION

On November 8, 2023, Notification of Intent 2B-1112-23 was approved to allow limbing of evergreen trees and removal of vegetation at 55148 Forest Lane in Bend, within the River Community Area of the Upper Deschutes State Scenic Waterway. This NOI was approved because the proposed work is outside of the 100' setback and will not meaningfully impact the amount of vegetation screening between the river and the existing house. This project complies with all relevant Upper Deschutes River Community Area rules.

On November 9, 2023, Notification of Intent number 53-233-23 was approved for both the installation of a new well, and the repair of all existing water infrastructure at Oxbow Regional Park. The project's location is Township 1S – Range 4E – Section 10, and Tax Lot 400, 800, 1S4E 15-00200, & 1S4E 11-00200. Project goals are to increase water delivery to the Park's Welcome Center with the addition of a new well. A secondary goal is to repair aging water infrastructure throughout the park to increase water quality for visitors. The project was approved because it complies with all relevant Sandy River State Scenic Waterway rules. This project will not alter or impair the scenic values in this section of the waterway.

On November 14, 2023 a Notification of Intent 14-31-23 was approved to Giustina Woodlands for a timber harvest of 4.4 acres within the McKenzie River Scenic Waterway of a 15 acre project area. 50% of the stand was dying due to the 2021 Holiday Farm fire. The operation does not impair any of the 870 feet of vegetation screening from the river's edge and adjacent terrain obscures any view of the project area from the river area.

On December 7, 2023, Notification of Intent 2B-1113-23 was approved to allow the construction of an open-sided shelter with a 4-foot wall on a newly poured concrete pad at 53539 Kokanee Way in La Pine, within the Pringle Falls River Community Area of the Upper Deschutes State

Scenic Waterway. The proposed project was approved because the work will take place outside of the 100' setback, will not involve vegetation removal or substantively change the view from the river, and will be built in materials and tones that conform to the surrounding natural landscape. This project complies with all relevant Upper Deschutes River Community Area rules.

On January 9, 2024 a Notification of Intent 9-428-24 was approved to Richard Clarke for a timber harvest of 2 acres out of 11 acres of ownership within the Clackamas River Scenic Waterway. The harvest to remove some hazard trees around the property owners' home was approved because the removals are not visible from view of the river. The operation does not impair any vegetation screening or create additional visibility of existing structures due to topography.

OCEAN SHORES ALTERATION DECISIONS

On January 12, 2024, permit 3045 was issued in Lincoln County to install a new public staircase and ramp structure at the end of Anchor Court in Lincoln City. This is currently an area of unimproved steep bluff slope with an irregular and unsafe travel surface.

On January 26, 2024, permit 3046 was issued in Clatsop County for sixty feet of riprap shoreline protective structure on the ocean shore adjacent to 3216 Pacific Street, in Cannon Beach, to replace a seawall that had previously failed.

TIMBER HARVEST REVENUE

On January 29, 2024 revenue of \$219,902.60 was received from Wayne Stone Logging. This was the final payment for the Fire Salvage/Daylighting Project at Silver Falls State Park where a total of 2.7 million board feet of timber was removed.
