Topic: All-Terrain Vehicle (ATV) Grant Recommendation

Background:

The All-Terrain Vehicle Grant Subcommittee met January 26 and 29, 2024, in Salem and via Zoom to review 16 grant applications totaling \$794,750. Five were Operations and Maintenance, five Emergency Medical Services, four Law Enforcement (LE), one Development and one Safety Education grant request. The ATV Grant program has \$15,000,000 in spending limitation for ATV grants for the 2023-2025 biennium. So far \$12,389,806 has been allocated, leaving \$2,610,194 in remaining funds.

The committee scored each grant request based on the applicant's presentation and application submitted. The scoring criteria were established in the 2016-2025 Oregon Statewide Trails Plan. The applications were ranked by the average of the scores given by the committee.

Ten of the Applications were for equipment purchases, mostly side-by-sides for Emergency Medical Services. Others were for staff to maintain riding areas or provide Law Enforcement. One application is to resurface asphalt in USFS staging areas, near Honeyman State Park. Funding was also requested for promoting the Tread Lightly! program in Oregon.

Upon approval, there will be \$1,815,443 will be remaining. Staff are working on another grant cycle over the summer of 2024.

Prior Action by Commission: At the April 13, 2023, Commission Meeting, \$8,039,013.71 was recommended for approval for Operations and Maintenance funding. At the June 14, 2023, Commission Meeting, \$3,975,801.19 was recommended for approval for Law Enforcement and other projects.

Action Requested: Commission approval for the ranking and distribution of ATV grants as recommended by the ATV Grant Subcommittee.
