Background:

Pursuant to a duly adopted delegation order, and acting in accordance therewith, the Director, or her designee, has approved the following actions on behalf of the Oregon Parks & Recreation Commission:

SCENIC WATERWAYS NOTIFICATION

- On November 15th, 2024, Notification of Intent 2C-218-24 was approved in a designated Recreational River Area of the Lower Deschutes State Scenic Waterway. The project, located at 8S14E12 tax lot 1302, is to remove and replace the existing farm dwelling and garage on the same footprint. With attached conditions, the approval is based on compatibility with existing use (farming).
- On November 16th, 2024, Notification of Intent 2B-1122-24 was approved in the Upper Deschutes State Scenic Waterway for improvements to an existing driveway. The project, located at 16322 Big Buck Ln., Bend, OR 97707 (tax lot#211003D009500 Deschutes County), is making improvements to an existing driveway including clearing small vegetation, grading, and rocking the existing footprint. The project was approved because it complies with all relevant Deschutes River Scenic Waterway rules.
- On November 25th, 2024, Notification of Intent 9-430-24 was approved in the Lower Clackamas State Scenic Waterway for a residential dwelling . The project is located at 45°20'55.22"North 122°23'11.57" West and within the Recreational River Area of the Lower Clackamas State Scenic Waterway. The residential dwelling is in response to a home that was lost during the 2020 Dowty wildfire. Most of the construction is blocked by topography, reforestation efforts have already occurred throughout the wildfire impacted area. The project was approved because it complies with all relevant Lower Clackamas Scenic Waterway rules. Within a reasonable timeframe the dwelling will not impede the scenic values of this river section as newly planted vegetation matures.
- On December 2nd, 2024, Notification of Intent 53-234-24 was approved in the Sandy River State Scenic Waterway for an addition to an existing home. The project is located at 45°31'1.60"North 122°20'36.87"West. The addition is expanding two bedrooms and adding a bathroom. The home is only visible from the southwest, the addition is on the east side of the house. After utilizing a

viewshed analysis it was determined that the addition will not be visible from the Sandy River. The project was approved because it complies with all relevant Sandy River Scenic Waterway rules.

- On December 2nd, 2024, Notification of Intent 2A-303-24 was approved for a fuels reduction project located on tax lots: 171217CC00600, 171217CC00700, 171217CC00800, 171217CC00900, 171218DD00300, 171218DD00200, 171218DD00100 & 171219AA01400 in Deschutes County. The project was approved because it complies with all relevant Deschutes River Scenic Waterway rules.
