Review Budget

• The agency budget package has gone to the governor and in the process of going to the legislature. The legislature must pass the budget. We're basing our numbers on what we had last year which was \$15 million for grants. We will go with that number for now. The amount may be different but should not be less.

• We have \$13.6 million in requests now, so we have enough to fund all requests. We do have another grant cycle with 14 grant applications, and we have about \$1.4 million to fund those. It is still early in the application process so we don't know what those numbers will look like.

Other Business

- Group discussion of site visits. Week of October 20-24 works for all committee members. Decided on Sumpter area and Mt Emily by La Grande. Staff will work on details.
 - Monday October 20 travel to Sumpter hotel
 - Tuesday October 21 Site visit to trails around Sumpter, Marble Pass hotel second night in Sumpter.
 - Wednesday October 22 Travel to La Grande to see Mt Emily. Potential to stop at Virtue Flat near Baker City.
 - Thursday October 23 Travel home. Potential to visit riding area on BLM near Hermiston

Staff has made room reservations in Sumpter 2 night and La Grande 1 night. Will continue to work on details.

- Ian two legislative bills related to ATVs. First is to change rulemaking authority from ODOT and DEQ to OPRD. HB 2232 (house bill). ODOT and DEQ are good with changing the authority to OPRD. This covers sound limits of ATVs(DEQ) and vehicle safety equipment, such as brakes, roll cage and flags (ODOT). Second from Representative Cate to allow the creation of street legal ATVs to be used on all roads in Oregon except interstates. HB 3155.
- Committee Term Limits. Virgle and Barrett are on the last year of their second term. End Date of December 31, 2025. Will need to recruit for Class II and Class III Representatives.
