The process for counting owners and objections is prescribed by federal law (Chapter 36, Code of Federal Regulations, part 60) and state rule [Oregon Administrative Rule (OAR) 736-050-0250]. Complete one form for each owner possessing fee simple absolute or fee simple defeasible estate title to real property.

A property is not listed in the National Register if the majority of private property owners holding fee simple absolute or fee simple defeasible estate title to real property object to listing. Each owner may only object once, no matter how many properties owned within the district. Owners may object, withdraw an objection, or assert ownership by submitting a valid statement on this form. Statements are accepted until the National Park Service makes its final decision.

The Oregon SHPO will acknowledge all persons in writing within 30 calendar days of receipt of their statement and any accompanying documents. The response will explain if the submitted statement and accompanying documents are valid or deficient. Rejected statements may be corrected and resubmitted until the National Park Service makes its final decision.

Please contact the office if the property is not on this list and you think it should be. Please keep this web site open until you have completed the following steps.
4. Legibly print on Line 2 the name of the owner exactly as it appears on the Property Owner List. Please contact the office if the property owner name is not listed and you think it should be.
5. Legibly print the legal name of the owner on Line 3 **only if different** from the owner name provided on Line 2 in any way.
6. Only complete Line 4 if representing an individual or entity other than you. If completing this line, documentation must be provided. See instruction #8.
7. Print the mailing address on Line 5, **only if different** from the property address on Line 1. Acknowledgement of the submitted statement will be sent to this address.
8. Indicate if you yourself are an owner or represent an owner. Check **only one** box.

Special note for trusts and other legal entities: While a legal representative of an owner may submit a statement on an owner's behalf, the representative must provide documentation demonstrating that they legally represent the owner. For a trust, a certification of trust that complies with ORS 130.860 is adequate documentation. Please refer to OAR 736-050-0250 for further information or contact the office with any questions.
