Located in Union County, Oregon, the Administration Building was listed in the National Register of Historic Places in 1980 for its significance in the areas of Architecture and Education.

The purpose of this additional documentation is to update the National Register nomination for the Administration Building to provide additional information on the Grand Staircase, which was listed as a contributing structure in the original nomination. In 2024, the original Grand Staircase was demolished and a new Grand Staircase has been built in its place.

Additional documentation provided herein updates Section 1, Section 7, Section 9, Section 10, and the Appendix from the current National Register of Historic Places nomination form to reflect the demolition and replacement of the Grand Staircase. The current name of the building, Inlow Hall, has been added as an additional property name under Section 1. Updates to Section 7 include a description of the original Grand Staircase and the circumstances of the removal; a physical description of the new Grand Staircase; and an analysis of its impact on the historic character-defining features of the property. Updates to Section 9 include additional bibliographic references used in completing this update. Updates to Section 10 include revisions to the acreage of the property, latitude and longitude coordinates, boundary description, and UTM coordinates, correcting or confirming previously unverified data through the use of updated mapping technology. Updates to the Appendix include the addition of a map outlining the boundary of the property and photographs of the replacement Grand Staircase.

#### **Narrative Description**

The Original Grand Staircase (no longer extant)

Eastern Oregon University's (EOU) Grand Staircase is located immediately north of the Administration Building (Inlow Hall) at the intersection of 9<sup>th</sup> Street and L Avenue. Constructed as a connection between the university and the adjacent residential neighborhood, the Staircase rises 42 feet in elevation from the intersection of 9th Street and L Avenue (at the north) to the Administration Building (at the south). Sloped wooded and landscaped areas demarcate the east and west borders of the staircase.

Architect John V. Bennes of Bennes and Herzog Architects, Portland, designed EOU's Administration Building and original Grand Staircase as an architectural unit in a modern adaptation of Italian Renaissance palatial architecture. Constructed of reinforced concrete and cast stone in 1929, the Grand Staircase was built into the hillside of an alluvial bench. This creates a northern view of La Grande and the surrounding valley and mountains from the overlook terrace at the top of the Grand Staircase. These lands include the traditional lands of the Cayuse, Umatilla, Walla Walla, and Nez Perce people.

The original Grand Staircase featured five tiers, 178 steps, and 418 balusters made from approximately 17,470 square feet of buff-colored concrete. The balustrade was molded cast stone with a concrete core and featured a pinkish hue that matched the cast stone of the Administration Building. The surrounding landscaping that was planted after the construction of the Staircase was not critical to the design of the Staircase; it has been modified several times since initial construction.

The layout of the original Grand Staircase featured three unique sections. Palladian in design, the symmetrical architectural elements and design of the Grand Staircase were mirrored on either side of the north-south uphill central axis. The lowest (northern) section of the original Grand Staircase was accessed at the intersection of L Avenue and 9th Street. Located in line with the crosswalk on either side of L Avenue, this section featured two entrances to the Staircase before a quarter turn stair on either side lead up to the northernmost landing. This landing, and the retaining wall below, curved outward toward L Avenue. On the ground level between the mirrored entrance sequence and quarter turn stair was a flat, landscaped area. Historically, landscaping included trees and shrubs lining the first retaining wall.

Aligning with the width of the first landing, the Staircase proceeded straight uphill along the central axis to a rectangular landing at the base of another retaining wall. To proceed further uphill, the stairs led outward (perpendicular to the central axis) to small landings, then switched back to meet at another rectangular landing at the opposite side of the retaining wall. This stair sequence essentially created a 180° turn leading up and around the central retaining wall.

Again, aligning with the width of the previous landings, the stairs proceeded straight uphill along the central axis leading to the southern section of the Staircase. Beginning with the southernmost landing at the bottom of the southern retaining wall, on either side of the landing, the stairs followed a concave arc leading up to the overlook terrace of the Grand Staircase at the top of the southern retaining wall, which was a half elliptical shape. The overlook terrace was located on an axis with the middle of the

Administration Building between the building's two north entrances. This arcing stair sequence leading to the overlook terrace was mirrored on either side of the Grand Staircase's central axis, and consequently provided two entrances at the top of the stair.

Each retaining wall featured a repetitive horizontal line design that was indented into the concrete. Lining the stairs and landings was a balustrade of molded cast stone with concrete core newel posts and balusters with cast stone top rails emulating Italian Renaissance Revival architecture. Six light posts were located symmetrically lining the outside edge of the Grand Staircase, three on either side. One was located at either side of the northern section entrances, one centered on either side of the small outside landings in the central section, and one located at either side of the southern entrances to the Staircase.

#### Alterations to Original Grand Staircase

In 1955, the graduating class sponsored the installation of the first two light posts at the southern entrances of the Grand Staircase. Adjacent to the overlook terrace, one light post was located on either outside edge of the southern entrances. A bronze plaque with the class of 1955 engraved was attached to each light post. These two lights were the first of the desired eight total light posts, although only a total of six light posts were eventually installed to complete the final design of the Grand Staircase.<sup>2</sup>

Between 1979 and 1980, EOU completed maintenance work on the Grand Staircase. Due to ground movement and La Grande's harsh winters, deterioration and crumbling of the concrete resulted in the need for EOU to excavate the northernmost landing and the stairs leading to and from the northernmost landing in order to strengthen the northernmost retaining wall. Supports were constructed on the uphill side of this retaining wall before dirt infill and a new landing and steps were rebuilt.<sup>3</sup>

Between 1983 and 1990, several balusters in the northernmost portion of the Grand Staircase were destroyed and subsequently replaced after a car was driven into the northernmost portion.<sup>4</sup> Since the completion of the maintenance project in 1980, further deterioration of the Grand Staircase has occurred due to ground movement and the harsh climate, resulting in EOU closing all access to the Staircase in 2003.<sup>5</sup> Restore Oregon, a statewide nonprofit preservation advocacy group, added the Grand Staircase to their Most Endangered Places list in 2015.<sup>6</sup>

#### Construction of New Grand Staircase

In 2022, the Oregon Legislature granted EOU \$4 million to return the Grand Staircase to a useable structure. In 2024, the original Grand Staircase was demolished in order to construct a new Grand Staircase that would withstand ground movement and the harsh eastern Oregon climate, two reasons that made the original Grand Staircase structurally fail, as well as align with current code. The new Grand Staircase was completed in 2025. Its construction did not harm any character-defining features of the Administration Building.

The new Grand Staircase was constructed in the same location as the original, is made of reinforced concrete, and features a similar design to that of the original Grand Staircase at both the north and south entrances, resembling the character-defining Palladian design of the original. However, due to a combination of the amount of funding and expensive material prices, the central portion of the new Grand Staircase was designed to be a straight-run stair with one central landing along the central axis, instead of the character-defining central retaining wall with landings and switchback stair. The design of the north convex retaining wall and the southern elliptical-shaped stair and overlook terrace remain similar, and the retaining walls feature the same horizontal line detailing as the original. The stairs and landings are lined by a metal guardrail and handrail system.

Although the new Grand Staircase is in the same location, shares a similar design, and is constructed of the same material as the original, there are several different elements that have impacted the character-defining features and integrity of the overall property. These include the change in the design of the central portion of the stair; the absence of the buff/pinkish hue that originally matched between the Administration Building and the original Grand Staircase; and the addition of metal handrails. In the future, as funding becomes available, EOU plans to install a precast concrete balustrade similar to the original, although with fewer balusters due to the design change, thus imitating the character-defining balustrade that was featured on the original Grand Staircase.

The views and sightlines of the property have not changed drastically with the construction of the new Grand Staircase, although the northernmost retaining wall was designed two feet higher than the original. Other additions to the property include two new, identical, updated interpretive signs telling the history of the Grand Staircase, one each at the north and south entrances of the Staircase. Additionally, the six existing light poles were restored and reinstalled with new globes. Existing landscaping, which has changed throughout the history of the original Grand Staircase, was removed in order to demolish and rebuild the Grand Staircase. The larger trees nearby were retained, and new landscaping is planned surrounding the Grand Staircase in the future.




