
## Upcoming Public Meetings

Join us for our third set of public meetings! OPRD planners have used feedback from park staff, the advisory committee, and members of the public to generate preliminary development concepts for many of the parks in the two management units. We will be sharing these concepts at a series of 'open house' meetings in Lincoln County in July (see the meeting details below). We welcome your feedback at these meetings.

## Highlights of proposed park improvements include:

- new disc golf course, parking, & trails at the South Jetty in Newport
- pedestrian connections & trail improvements at Yaquina Bay State Park
- new sports field and parking improvements at Agate Beach State Recreation Site
- new campground & day use improvements at Fogarty Creek State Park
- proposals for a variety of facility and natural resource improvements at Driftwood Beach, L. Presley & Vera C. Gill, Seal Rock, Beverly Beach, and Gleneden Beach

### What Happened at Meeting I

At our first set of meetings in February 2015, we introduced the state parks in the Beverly Beach and South Beach Management Units and explained how the planning process will guide the vision and management of those parks for the next 15–20 years and beyond. We also asked members of the public to tell us what they value about Oregon's Central Coast and its state parks. ### What Happened at Meeting II

At the second set of public meetings we presented summaries of existing condition assessments and reviewed opportunities and constraints for the parks as well as the management units as a whole. **Fall or Winter 2016**

At our final set of public meetings staff will present the draft plan and invite comments. The draft plan will include summaries of the assessments, public input, values, goals, strategies for park management, natural resource conservation and development, and recommendations for the future vision and management of the state parks in the South Beach and Beverly Beach Management Units.
