Regarding the closure of the beach access at NW 15th street in Lincoln City:

- The closure over the summer has been very successful. More families and walkers are enjoying the beach. There are no late night vehicles doing wheelies and/or driving up and down the beach.
- I recommend it stays closed.
- If not change the nomenclature it's not a driving on the beach access. It's a place to park on the beach with very limited availability. No cars can actually drive on the beach legally except within the 150 ft markers.
- I do not recommend widening the parking area. This solves nothing. The issue is safe access. The beach access is only wide enough for one vehicle at a time to either go up or down. It's already a traffic nightmare at the 15th street area when in place.
- There is no full time monitoring of the parking. Many vehicles ignore the signs and DRIVE down to the D River especially at night..
- This summer closure has brought less issues, more enjoyment and a safer beach experience.
