




- \$3.45 million in leveraged funds (*first biennium*)

### **Outdoor School First Biennium**

- 130 new schools
- 14,000 new students



- When asked to rate the development of students' leadership, critical thinking, and decision-making skills, early 85 percent of schools rated this a 4 or a 5.
- 5
- 92 percent of schools reported that their outdoor school curriculum and content significantly addressed science.

# Outdoor Education: Outdoor School and Beyond

- Develop statewide framework and funding for K-12 Outdoor education learning (build upon Oregon Environmental Literacy Plan, Oregon Natural Resources Education Program, Academic Standards, and Outdoor School)
- 2. Continued funding for Statewide Outdoor School Program



# Extended Policy Recommendations



### **Outdoor Recreation: Extended Access**

- 1. Continue effort to develop ONE PASS system for Oregon public lands and parks (National Agenda as well)
- 2. Develop plan and target dates for gender neutral restrooms in state facilities (ands provide guidelines for local agencies)
- 3. Fund strategic plan and timeline for translation of trail head information, publications, safety information, guides and websites



### **Outdoor Recreation: Extended Access**

- 4. Provide EDI training program for state recreation/lands/parks employees (public interaction, policy makers, planners)
- 5. Develop plan with local tribes for land acknowledgement and history at all public parks, lands, facilities (signage and history) and establish task force to evaluate existing information for bias or erasure (decolonize the story)—guidelines for local agencies





### **Outdoor Recreation: Extended Access**

- 6. Evaluate all public parks/lands/facilities for accessibility, prioritize needs, and launch (and fund) plan to upgrade facilities to ensure equitable access for all—better publicize current accessibility of sites and progress of upgrades
- 7. More state support for Employee Resource Groups (ERGs) for marginalized communities
