Meeting Opening

- Meeting chaired and called to order at 12:02pm by Chair Barnes
- No public comments were received
- Quorum was reached

AmeriCorps & Legislative Updates

Federal and State Activities

- Director Bauer provided updates on the preliminary injunction (PI). Guidance
 was received from AmeriCorps last week and previous members who had been
 exited as part of the original executive order were reinstated. No-cost
 extensions can be extended, education awards, and other funding have been
 re-issued.
- Director Bauer shared information detailing how members who were exited early will be impacted.
- Director Bauer discussed FY-25 contracts that were approved in March and the results of the grant applications, as well as notices that were sent to programs stating that there is a new funding condition.
- Director Bauer talked about the importance of reviewing a large swath of programming within the state even those other AmeriCorps programs that are not funded through OregonServes.

- Director Bauer shared a spreadsheet outlining some of the bills that came out
 of the legislation session through Basecamp. A key collaborative area for
 legislative concepts is within Youth Mental Health. She also shared a draft
 Legislative Concept Development Calendar for the Committee's review.
- Daniel shared that there were relationships and work previously done by other states' that is similar, that can be leveraged in this work and create opportunities.
- Director Bauer mentioned that it would behoove us to start thinking about finalizing drafts for the next long legislative session in 2027.
- Director Bauer is reaching out to state programs to collect data.

Invited Testimony on AmeriCorps Seniors Programs

Cassie was not present to give testimony at the meeting.

Committee Business

- Announcements and updates were given by Director Bauer:
