Commission Operations Report

Review & Updates, Presented by Director Bauer

- Director Bauer provided updates on Commission operational and strategic activities:
 - Membership Committee has met and is reviewing the new Commission process and policy drafts. The Committee still needs a chair. Recruitment

- need will be advertised at upcoming Commission meeting to generate interest.
- o Preliminary Injunction in multistate lawsuit update.
- Anticipated funding updates Commission Support Grant (CSG) and Commission Investment Fund (CIF) awards expected by June 20, per AmeriCorps' stated updates.
- State Plan Development opening planning session expected to occur at Commission Annual Retreat in September.
- NGA Service-to-Career Pathway Policy Academy is continuing to meet. The team, led by Director Bauer, is discussing strategies to support Youth Mental Health Corps (YMHC) planning and implementation in event federal funding continues to be at issue.
- Director Bauer shared a draft agenda for the July Commission meeting.
 Committee members discussed potential guest speakers for Director Bauer to pursue, including a member from the Commission's national association, or an in-depth update on YMHC activities.
- Commissioner Barnes also provided an update on the draft Commission outreach letter.
 - Noting the 30-minute meeting time the Executive Committee was trying out did not seem to provide enough time, Commissioner Barnes made a motion to change the start time of future meetings to 12:15pm, instead of 12:30pm. Vice-Chair Altamirano Hernandez seconded. The motion passed with a consensus vote from all members of the Executive Committee.
