# **Meeting Opening:**

# **Invited Public Testimony: OregonServes AmeriCorps State Grantees**

Program and Planning Grant grantees were invited to provide, via written or verbal testimony, information on the impacts to their programs from the recent federal executive orders, an impending threat of a government shutdown, and the pending federal budget cuts. Carmen Denison, Executive Director, Coalition for Racial and Educational Justice, (CoREJ) and Adriana Lovell, Board Director, Confluence Environmental Center, provided verbal testimony to the Commission.
